Becoming Hitler

In Becoming Hitler, Thomas Weber continues from where he left off in his previous book, Hitler's First War, stripping away the layers of myth and fabrication in Hitler's own tale to tell the real story of Hitler's politicization and radicalization in post-First World War Munich. It is the gripping account of how an awkward and unemployed loner with virtually no recognizable leadership qualities and fluctuating political ideas turned into thecharismatic, self-assured, virulently anti-Semitic leader with an all-or-nothing approach to politics with whom the world was soon to become tragically familiar. As Weber clearly shows, far from the picture of afully-formed political leader which Hitler wanted to portray in Mein Kampf, his ideas and priorities were still very uncertain and largely undefined in early 1919 - and they continued to shift until 1923.

Hitler's True Believers

Understanding Adolf Hitler's ideology provides insights into the mental world of an extremist politics that, over the course of the Third Reich, developed explosive energies culminating in the Second World War and the Holocaust. Too often the theories underlying National Socialism or Nazism are dismissed as an irrational hodge-podge of ideas. Yet that ideology drove Hitler's quest for power in 1933, colored everything in the Third Reich, and transformed him, however briefly, into the most powerful leader in the world. How did he discover that ideology? How was it that cohorts of leaders, followers, and ordinary citizens adopted aspects of National Socialism without experiencing the \"leader\" first-hand or reading his works? They shared a collective desire to create a harmonious, racially select, \"community of the people\" to build on Germany's socialist-oriented political culture and to seek national renewal. If we wish to understand the rise of the Nazi Party and the new dictatorship's remarkable staying power, we have to take the nationalist and socialist aspects of this ideology seriously. Hitler became a kind of representative figure for ideas, emotions, and aims that he shared with thousands, and eventually millions, of true believers who were of like mind . They

projected onto him the properties of the \"necessary leader,\" a commanding figure at the head of a uniformed corps that would rally the masses and storm the barricades. It remains remarkable that millions of people in a well-educated and cultured nation eventually came to accept or accommodate themselves to the tenants of an extremist ideology laced with hatred and laden with such obvious murderous implications.

Adolf Hitler Life Story

Adolf Hitler was born on 20 April 1889 in the small Austrian town of Braunau to Alois Hitler who later became a senior customs official and his wife Klara, who was from a poor peasant family. At primary school, Hitler showed great intellectual potential and was extremely popular with fellow pupils as well as being admired for his leadership qualities. However, competition at secondary school was tougher and Hitler stopped trying as a result. He also lost his popularity among his fellow students and instead preferred to reenact battles from the Boer war with younger children. At the age of 15, he failed his exams and was told to repeat the year but he left without a formal education instead. At the age of 18, he moved to Vienna with money inherited after his father's death in 1903, in order to pursue a career in art, as this was his best subject at school. However his applications for both the Vienna Academy of Art and the School of Architecture were rejected. It was supposedly at this time that Hitler first became interested in politics and how the masses could be made to respond to certain themes. He was particularly impressed with the anti-Semitic, nationalist Christian-Socialist party. During the First World War he volunteered to fight for the German Army and gained the rank of corporal, earning accolades as a dispatch-runner. He won several awards for bravery, including the Iron Cross First Class. In October 1918, he was blinded in a mustard gas attack. Germany surrendered while Hitler was in hospital and he went into a state of great depression, spending lots of time in tears. After the war ended, Hitler's future seemed uncertain. In 1919, Hitler attended his first meeting of the German Workers' party, an anti-Semitic, nationalist group as a spy for the German Army. However, he found he agreed with Anton Drexler's German nationalism and anti-Semitism. He disagreed with how they were organised leading him to make a passionate speech. Hitler quickly cemented his reputation as an engaging orator through his passion about the injustices faced by Germany as a result of the Treaty of Versailles. It soon became clear that people were joining the party just to see Hitler make his speeches, which would leave the audience in a state of near hysteria and willing to do whatever he suggested. He quickly rose through the ranks and, by 1921, was the leader of the re-named National Socialist German Workers' Party (Nazi). With terrible economic conditions and rapid inflation, support for Hitler's party grew. By 1923, the Nazi's had 56,000 members and many more supporters. On 8 and 9 November 1923, Hitler staged the Nazi Beer Hall Putsch. He hoped to force the Bavarian government to work with the Nazis and march together on Berlin. The attempt failed but, although Hitler was tried for treason, the judge gave him a very light sentence. While in prison, Hitler wrote 'Mein Kampf', which formulated his political ideas. He reorganised his party on his release from jail, but it was not until the world depression hit Germany that the Nazis were able to attract significant followers. By 1930, the Nazis were polling around 6.5 million votes. In the presidential elections of 1932, Hitler came second. On 30 January 1933, President Hindenburg was forced to appoint Hitler as Chancellor, given his popular support. In office, Hitler set about consolidating his power, appointing Nazis to government and gaining control of emergency powers. He eliminated all opposition, in the name of emergency control and, with the death of Hindenburg in 1934, Hitler's power was secured...

Adolf Hitler

This text is Jones's account of his part in British Scientific Intelligence between 1939 and 1949. It was his responsibility to anticipate German applications of science to warfare, so that their new weapons could be countered before they were used. Much of his work had to do with radio navigation, as in the Battle of the Beams, with radar, as in the Allied Bomber Offensive and in the preparations for D-Day and in the war at sea. He was also in charge of intelligence against the V-1 (flying bomb) and the V-2 (rocket) retaliation weapons and, although the Germans were some distance behind from success, against their nuclear developments.

IN APRIL 1977 the publishing worlds of London and New York were startled by the appearance of David Irving's Hitler's War (Hodder & Stoughton, Ltd. and The Viking Press Inc.) It was unique among biographies in its method of describing a major historical event - World War Two through the eyes of one of the dictators himself. 'What Hitler did not order, or did not learn, does not figure in this book,' explains the author. 'The narrative of events unfolds in the precise sequence that Hitler himself became involved in them.' The first that the reader knows of a plot against Hitler's life is when the army traitor Count von Stauffenberg's bomb explodes beneath the table at the Führer's headquarters. The investigation follows. It is an unusual technique, but it works. The book sold thirty thousand copies in its first UK hardback edition and was often reprinted and translated after that. It became a recommended reference work at West Point, at Sandhurst, in military academies around the former Empire and in university libraries around the world, because it quoted diaries and documents that other famous historians had not troubled to find. In 1991 Focal Point prepared a new edition, updated, revised and included The War Path, the author's narrative of Hitler's prewar years. This was a timely precaution, as Mr Irving's other publishers were now coming under a systematic and orchestrated attack: In July 1992, on the day after he returned triumphantly from Moscow bringing the unpublished Goebbels diaries from former KGB archives, his main publisher, Macmillan Ltd., secretly ordered all remaining copies of their editions of his books burned. The Holocaust Educational Trust began a campaign to smash the windows of bookstores selling his books - Nottingham, Newcastle, and Norwich were among the first. Public Libraries were requested to pull his books from their shelves. Italian, French, Spanish, and Scandinavian publishers who had rights to translate the massive work were prevailed upon never to release it.

The Rise and Fall of the Third Reich

Many of these thinkers supported moral relativism, yet simultaneously exalted evolutionary 'fitness' (especially intelligence and health) to the highest arbiter of morality. Darwinism played a key role in the rise not only of eugenics, but also euthanasia, infanticide, abortion and racial extermination. This was especially important in Germany, since Hitler built his view of ethics on Darwinian principles, not on nihilism.

Adolf Hitler was chancellor of Germany from 1933 to 1945, serving as dictator and leader of the Nazi Party, or National Socialist German Workers Party, for the bulk of his time in power. From 1933 onward, Nazi Germany undertook massive and unprecedented industrial integration, submitting an entire economic sector to direct state oversight. While Jakob Reichert of the iron and steel industry unexpectedly resisted state control and was eventually driven to suicide, Karl Lange of the machine builders' association achieved security for himself and his industry by submitting to the Nazi regime. Whitman looks at the ultimate, ugly irony that when Nazis rejected American practices, it was sometimes not because they found them too enlightened, but too harsh. Indelibly linking American race laws to the shaping of Nazi policies in Germany, Hitler's American Model upends understandings of America's influence on racist practices in the wider world.\" --
