## Missing and Exploited Children

The book comprises country reports of the 10 new EU Member States. Each country report provides essential

definitional information regarding the various forms of sexual exploitation of children and types of missing children, outlines the way data collection on sexual exploited and missing children by various governmental (police, judicial, other) and nongovernmental actors is organised, and delivers available data on the phenomena concerned. A final, comparative report bridges the country report information into a first epidemiological state of the art for the 10 new Member States and for the entire enlarged EU, comparing the newly gathered information with information collected in the initial 15 Member States during a previous study, the report of which has been published in January 2004 as the first book in the Childscope series.

## **Conservation of Exploited Species**

Economic dimensions have been somewhat neglected in research on nature policy and management of marine ecosystem exploitation. The current book aims to fill this gap. It examines the mismatches of natural, socio-economic, and regulatory processes and regimes in time and space. This involves dealing with the complexity and uncertainty that are inherent to the interaction of marine ecosystems and economic systems. The approach adopted is based on the idea that the design of sustainability policies requires an integration of insights from resource, environmental, and ecological economics on the one hand and marine biology and environmental sciences on the other hand. For this purpose, use is made of integrated assessment on the basis of theoretical and applied mathematical models. The book is the result of a large project, hosted by the Department of Spatial Economics of the Free University in Amsterdam, under the supervision of the first author.

The project received funding from the Netherlands Organisation for Scientific Research (NWO), through a "priority program" titled "Sustainable Use and Conservation of Marine Living Resources," which was initiated and coordinated by Prof. Wim Wolff of the University of Groningen. The work reported here has greatly benefited from external advice given by marine biologists who participated in this research program.

## **Missing and Exploited Children**

This book examines the legality, adequacy and efficacy of using the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) for commercially-exploited fish species and assesses whether the existing institutional cooperation with the Food and Agriculture Organization (FAO) and regional fisheries management organizations (RFMOs) is efficient. This case-study also provides an interesting lens to approaching wider international law issues. Indeed, finding ways to achieve effective governance of transboundary or global natural resources is central to the peaceful use of oceans and land. Furthermore, the role of science in advising decision-makers is a sensitive issue, which deserves scrutiny and is similar in many regimes. Finally, the complex problem of fragmentation of international law is acute in various fields of environmental law, as in all rapidly developing areas of international regulations.

## **Missing and Exploited Children's Training Program**

Concern about missing and exploited children gained national prominence in 1981 when Adam Walsh, the 6-year-old son of John and Reve Walsh was abducted and subsequently found murdered. A year later, with the help of other parents of abducted children, the Walshes worked for the passage of the Missing Children's Act of 1982 and later for the Missing Children's Assistance Act of 1984, to assist in recovering such children and bringing perpetrators to justice. The Missing, Exploited and Runaway Children Protection Act that was instituted in 1999 reauthorised and amended the Missing Children's Assistance Act of 1984. This book presents an overview of the issues that face the legislation pertaining to missing and exploited children. In addition, the book discusses the various efforts that are being taken to enhance the ability to locate the missing children. ## **America's Missing & Exploited Children**

Biological Diversity takes a fresh, innovative approach to the teaching of biodiversity. Rather than detailing and cataloguing the major taxa and their evolutionary relationships, the authors have selected 18 groups of organisms and used these as a framework in which to discuss the species and their interactions with man and each other. There is a strong narrative theme throughout – the exploited and the exploiters - and, in many cases, there is emphasis on the historical context. A wide range of organisms are covered, from the unicellular to birds and mammals and with an equal consideration of plants and animals. Species have been chosen for their ability to best illustrate particular biological principles, and for their strong interaction with other species. After an introduction the book is divided into two parts: 'Exploited' and 'Exploiters'. Each of the chapters, although linked to each other, forms a stand-alone essay. They are scientifically rigorous, up-to-date and do not shy away from addressing some controversial issues. Chapters have 'text boxes' highlighting important issues and concepts, lists of further reading and references. In addition to tables and figures the book has a selection of original illustrations drawn by leading artist Steven Appleby. This fresh approach will appeal to all those interested in the biological sciences, and aims to be accessible to people with a diversity of backgrounds. It will prove particularly useful to biology students, enabling them to get to grips with important biological principles and concepts that underpin the diversity of life, and the interrelationship of humans with other groups of organisms.

## **The Use of CITES for Commercially-exploited Fish Species**

Several decades ago, the efforts of public administrations were concentrated on developing fisheries and aquaculture and ensuring growth in production and consumption. Then, in the 1980s, as many resources became fully or overexploited, the attention of policy-makers began to focus instead on fisheries management, in addition to development of aquaculture. Subsequent recognition of the many failures in management have now led FAO member countries and other relevant stakeholders to broaden the approach and governance, that is, the sum of the legal, social, economic and political arrangements used to manage fisheries and aquaculture in a sustainable manner is currently seen as a necessary context for management and is becoming the main concern. Aquaculture continues to expand, while marine capture fisheries - when summed together worldwide - seem to have reached a ceiling. Reflecting the growing importance of aquaculture, The State of World Fisheries and Aquaculture ends with a discussion of the challenges that aquaculture is facing as well as of the opportunities that are open to the sector. The discussion is based on a

prospective analysis of the aquaculture sector worldwide, which was undertaken by FAO in the past two years.
