Disability and Medieval Law

Disability and Medieval Law: History, Literature and Society is an intervention in the growing and complex field of medieval disability studies. The size of the field and the complexity of the subject lend themselves to the use of case studies: how a particular author imagines an injury, how a particular legal code deals with (and sometimes creates) injury to the human body. While many studies have fruitfully insisted on theoretical approaches, Disability and Medieval Law considers how medieval societies directly dealt with crime, punishment, oath-taking, and mental illness. When did medieval law take disability into account in setting punishment or responsibility? When did medieval law choose to cause disabilities? How did medieval authors use disability to discuss not only law, but social relationships and the nature of the human? The volume includes essays on topics as diverse as Francis of Assissi, Margery Kempe, La Manekine, Geoffrey Chaucer, early medieval law codes, and the definition of mental illness in English legal records, by Irina Metzler, Wendy J. Turner, Amanda Hopkins, Donna Trembinski, Marian Lupo and Cory James Rushton.

Profinite Groups

The aim of this book is to serve both as an introduction to profinite groups and as a reference for specialists in some areas of the theory. The book is reasonably self-contained. Profinite groups are Galois groups. As such they are of interest in algebraic number theory. Much of recent research on abstract infinite groups is related to profinite groups because residually finite groups are naturally embedded in a profinite group. In addition to basic facts about general profinite groups, the book emphasizes free constructions (particularly free profinite groups and the structure of their subgroups). Homology and cohomology is described with a minimum of prerequisites. This second edition contains three new appendices dealing with a new characterization of free profinite groups, presentations of pro-p groups and a new conceptually simpler approach to the proof of some classical subgroup theorems. Throughout the text there are additions in the form of new results, improved proofs, typographical corrections, and an enlarged bibliography. The list of open questions has been updated; comments and references have been added about those previously open problems that have been solved after the first edition appeared.

Goal-based Decision Making

This work presents a goal-based model of decision making in which the relative priorities of goals drive the decision process -- a psychological alternative to traditional decision analysis. Building on the work of Schank and Abelson, the author uses goals as the basis for a model of interpersonal relations which permits decisions to incorporate personal and adopted goals in a uniform manner. The theory is modelled on the VOTE computer program which simulates Congressional roll-call voting decisions. The VOTE program expands traditional decision making and simulation models by providing not only a choice, but also a natural language explanation, in either English or French. It simulates real members of Congress voting on real bills, and producing reasonable explanations. The program is consistent with much of the descriptive political science literature on Congressional decision making and provides an explicit model of political issues, relationships, and strategies that converge in voting behavior. In developing the VOTE program, the author draws on his own practical experience in politics from four presidential campaigns and the White House. Given the underlying psychological basis of the program, VOTE can be extended to other decision making domains different from politics. Another use for the program is to simulate business decisions such as securities analysis, as well as mundane decision making such as choosing a college or deciding whether to get a Mohawk haircut.

Field Arithmetic

Field Arithmetic explores Diophantine fields through their absolute Galois groups. This largely self-contained treatment starts with techniques from algebraic geometry, number theory, and profinite groups. Graduate students can effectively learn generalizations of finite field ideas. We use Haar measure on the absolute Galois group to replace counting arguments. New Chebotarev density variants interpret diophantine properties. Here we have the only complete treatment of Galois stratifications, used by Denef and Loeser, et al, to study Chow motives of Diophantine statements. Progress from the first edition starts by characterizing the finite-field like P(seudo)A(lgebraically)C(losed) fields. We once believed PAC fields were rare. Now we know they include valuable Galois extensions of the rationals that present its absolute Galois group through known groups. PAC fields have projective absolute Galois group. Those that are Hilbertian are characterized by this group being pro-free. These last decade results are tools for studying fields by their relation to those with projective absolute group. There are still mysterious problems to guide a new generation: Is the solvable closure of the rationals PAC; and do projective Hilbertian fields have pro-free absolute Galois group (includes Shafarevich's conjecture)?

Profinite Graphs and Groups

This book offers a detailed introduction to graph theoretic methods in profinite groups and applications to abstract groups. It is the first to provide a comprehensive treatment of the subject. The author begins by carefully developing relevant notions in topology, profinite groups and homology, including free products of profinite groups, cohomological methods in profinite groups, and fixed points of automorphisms of free proparoups. The final part of the book is dedicated to applications of the profinite theory to abstract groups, with sections on finitely generated subgroups of free groups, separability conditions in free and amalgamated products, and algorithms in free groups and finite monoids. Profinite Graphs and Groups will appeal to students and researchers interested in profinite groups, geometric group theory, graphs and connections with the theory of formal languages. A complete reference on the subject, the book includes historical and bibliographical notes as well as a discussion of open questions and suggestions for further reading.

Revealing Creativity

This book presents the proceedings of the 32nd International Conference on Legal Knowledge and Information Systems (JURIX 2019), held in Madrid, Spain, from 11 to 13 December 2019. Traditionally focused on legal knowledge representation and engineering, computational models of legal reasoning, and analyses of legal data, more recently the conference has also encompassed the use of machine learning tools. A total of 81 submissions were received for the conference, of which 14 were selected as full papers and 17 as short papers. A further 3 submissions were accepted as demo presentations, resulting in a total acceptance rate of 41.98%, with a competitive 25.5% acceptance rate for full papers. The 34 papers presented here cover a broad range of topics, from computational models of legal argumentation, case-based reasoning, legal ontologies, and evidential reasoning, through classification of different types of text in legal documents and comparing similarities, to the relevance of judicial decisions to issues of governmental transparency. The book will be of interest to all those whose work involves the use of knowledge and information systems in the legal sphere.

Highway Accident Report

The construction of a church was undoubtedly one of the most demanding events to take place in the life of a medieval parish. It required a huge outlay of time, money and labour, and often a new organisational structure to oversee design and management. Who took control and who provided the financing was deeply shaped by local patterns in wealth, authority and institutional development - from small villages with little formal government to settlements with highly unequal populations.
