In this critical analysis Enrico Mazza concentrates on structure as he traces the evolution of the Eucharistic Prayer (anaphora) from its origins in the ancient Jewish rites and its Christian beginnings in the Didache. He then examines the paleoanaphoras of the early centuries and moves through the origin and progressive development of the larger anaphoric families (Alexandrian, Roman, Antiochene), showing the influence of the Jewish rites on the formation of the Christian texts before arriving finally at the classical anaphoras of the fourth century. Enrico Mazza is professor of liturgical history at the Universit... Cattolica del Sacro Cuore in Milan. He is the author of *Mystagogy: A Theology of Liturgy in the Patristic Ages* and *Eucharistic Prayers of the Roman Rite*.

Philosophy in the medieval Latin West before 1200 is often thought to have been dominated by Platonism. The articles in this volume question this view, by cataloguing, describing and investigating the tradition of Aristotelian logic in the period, examining its influence on authors usually placed within the Platonic tradition (Eriugena, Anselm, Gilbert of Poitiers), and also looking at some of the characteristics of early medieval Platonism. Abelard, the most brilliant logician of the age, is the main subject of three articles, and the book concludes with two more general discussions about how and why medieval philosophy should be studied.

Aristotelian Logic, Platonism, and the Context of Early Medieval Philosophy in the West

Published in 1863, these texts illuminate twelfth-century scientific knowledge and theology in prose and verse form.

On nature and grace. Philosophical introduction

Essays examine how the genre of *historia* reflects connections between the study of nature and the study of culture in early modern scholarly pursuits. The early modern genre of *historia* connected the study of nature and the study of culture from the early Renaissance to the eighteenth century. The ubiquity of *historia* as a descriptive method across a variety of disciplines--including natural history, medicine, antiquarianism, and philology--indicates how closely intertwined these scholarly pursuits were in the early modern period. The essays collected in this volume demonstrate that *historia* can be considered a key epistemic tool of early modern intellectual practices. Focusing on the actual use of *historia* across disciplines, the essays highlight a distinctive feature of early modern descriptive sciences: the coupling of observational skills with philological learning, empiricism with erudition. Thus the essays bring to light previously unexamined links between the culture of humanism and the scientific revolution. The contributors, from a range of disciplines that echoes the broad scope of early modern *historia*, examine such topics as the development of a new interest in historical method from the Renaissance *artes historicae* to the eighteenth-century tension between "history" and "system"; shifts in Aristotelian thought paving the way for revaluation of *historia* as descriptive knowledge; the rise of the new discipline of natural history; the uses of *historia* in anatomical and medical investigation and the writing of history by physicians; parallels between the practices of collecting and presenting information in both natural history and antiquarianism; and significant examples of the ease with which early seventeenth-century antiquarian scholars moved from studies of nature to studies of culture.

La critica dei pregiudizi va unita alla critica della conoscenza e alla capacità di discutere la coerenza e la validità dei sistemi di scopi che governano la prassi.
