A fiduciary duty is the legal responsibility to act solely in the best interest of another party.

For example, lawyers have a fiduciary duty to act in the best interest of their clients.

Similarly, physicians have a duty to care for, and act in, the best interest of their patients.

Likewise, trustees have a duty to manage the assets of a trust for its beneficiaries

and directors to manage corporate assets in the best interests of shareholders.
