Franco

On 20th November 1975, General Francisco Franco died in Madrid, just before his 83rd birthday. At the time of his death he had been the head of a dictatorial regime with the title of 'Caudillo' for almost 40 years. In this book, Enrique Moradiellos redraws Franco in three dimensions - Franco, the man; Franco, the Caudillo and Franco's Spain. In so doing, he offers a reappraisal of Franco's personality, his leadership style and the nature of the regime that he established and led until his death. As a dictator who established his power prior to World War II and maintained it well into the 1970s, Franco was one of the most central figures of twentieth-century European history. In Spain today, he is a spectre from a regrettable recent past, uncomfortable yet still very real and significant. Although a realtively minor dictator in comparison with Mussolini, Hitler or Stalin, Franco was more fortunate than them in terms of survival, long-lasting influence and public image. A study of his regime and its historical evolution sheds new light on fundamental questions of European history, including the social and cultural bases for totalitarian or authoritarian challenges to democracy and sources of political legitimacy grounded in the charisma of a leader. In this book, Enrique Moradiellos Garcia examines the dictatorship as well as the dictator and, in doing so, reveals new aspects to our understanding of General Franco, the Caudillo.

Fighting For Franco

During the Spanish civil war, however, many groups on the European right were galvanized by the Nationalist cause. European fascists, conservative Catholics and those uneasy with liberal democracy in general rallied to the figure of Franco, who appeared to be holding the line against secularism, modernism and Bolshevism. This book recounts the experiences of a number of foreign volunteers, including the brigades of White Russians, Romanians, Irish and the French volunteers in the Jeanne d'Arc battalion, all of whom saw their engagement in Spain as a means of promoting their own political causes at home. As well there were individual women

and men, from the New World and the Old, who were moved by religion, politics or simply adventurism to join up with Franco. Fighting for Franco reconstructs their motivation and the mind set which took them to Spain. It thus casts a new light on Nationalist Spain and on the specific concerns of a wide variety of right-wing movements between the wars.

A People Betrayed

From the foremost historian of 20th century Spain, A People Betrayed is the story of the devastating betrayal of Spain by its political class, its military and its Church. This comprehensive history of modern Spain chronicles the fomenting of violent social division throughout the country by institutionalised corruption and startling political incompetence. Most spectacularly during the Primo de Rivera and Franco dictatorships, grotesque and shameless corruption went hand-in-hand with inept policies that prolonged Spain's economic backwardness well into the 1950s. Franco's Friends

Born in 1892 in El Ferrol, Spain, Franco was a career soldier who rose through the ranks until the mid-1930s. When the social and economic structure of Spain began to crumble, he joined the growing right-leaning rebel movement. He soon led an uprising against the leftist Republican government and took control of Spain following the bloody Spanish Civil War (1936-39) when, with the help of Nazi Germany and Fascist Italy, his Nationalist forces overthrew the democratically elected Second Republic. Franco then presided over a brutal military dictatorship, persecuting political opponents, repressing the culture and language of Spain's Basque and Catalan regions, and censuring the media. He died in Madrid in 1975, as Spain transitioned to a democracy. What is left of Francisco Franco's legacy in Spain today? Franco ruled Spain as a military dictator from 1939 until his death in 1975. In October 2019, his remains were removed from the massive national monument in which they had been buried for forty-four years. For some, the exhumation confirmed that Spain has long been a modern, consolidated democracy. The reality is more complicated. In fact, the country is still deeply affected by the dictatorial legacies of Francoism. In one short volume, Exhuming Franco covers all major facets of the Francoist legacy today, combining research and analysis with reportage and interviews. This book is critical of Spanish democracy; yet, as the final chapter makes clear, Spain is one of many countries facing difficult questions about a conflictive past. To make things worse, the rise of a new, right-wing nationalist revisionism across the West threatens to undo much of the progress made in the past couple of decades when it comes to issues of historical justice.

Franco and Hitler

Spain has no foolish dreams.\" - Francisco Franco The Spanish Civil War has exerted a powerful impact on the historical imagination. Without question, the conflict was a key moment in the 20th century, a precursor to World War II, and an encapsulation of the rise of extremist movements in the 1930s, but it was also a complex narrative in and of itself, even as it offered a truly international theatre of war. It marked one of the seminal moments, along with the 1929 Wall Street Crash, between the two apocalyptic wars of the early 20th century, and since it occurred between 1936 and 1939, Spain proved to be a testing ground of tactics, weaponry, and ideology ahead of World War II. For the Allied powers Britain and France, Spain became a nadir of \"appeasement,\" yet, as the name suggests, the conflict had distinctly Spanish characteristics. The pressures that led to war were particular to the country, its social challenges, and its long and intricate history, and it was a conflict between two sides that included disparate elements like the clergy, socialists, landowners, and even anarchists. It is estimated that somewhere between 500,000-2,000,000 people were killed in the war. Unlike World War II, the Spanish conflict attracted artists and writers, many of whom reflected upon events and even volunteered to fight. Pablo Picasso's painting Guernica, journalist Martha Gellhorn's reports, Robert Capa's iconic photography, George Orwell's Homage to Catalonia, and Ernest Hemingway's For Whom the Bell Tolls are just some examples of the art and literature that documented the war, and 80 years later, the conflict and its causes still inspire musicians and writers. Ultimately, the forces of reaction, led by General Francisco Franco, triumphed, and after his victory in 1939, Franco ruled Spain with an iron fist for 36 years. Thus, it's only natural that Franco's rapid yet unlikely rise to power in Spain came to define a country for several generations. Franco was influenced by the wider trends and forces of the 20th century, yet he would indelibly make his mark on Spain in his own right, and in the process become one of the most widely derided figures in contemporary history. After his victory in the Spanish Civil War, Franco used political ideas and ideology as it suited him, though he did seem to advocate conservatism, militarism, Catholicism and monarchism. Franco adeptly steered Spain through the Second World War and the Cold War without really committing the country to any specific engagements, but he still managed to secure support and backing from more powerful allies. For the people of Spain, however, Franco was far from the benevolent figurehead he portrayed himself to be. Franco's rule was vicious and spiteful, and persecution and oppression were ever present during his dictatorship. Franco's Spain was intolerant of dissent, and by the 1970s, the country appeared to outsiders to be completely under his control and influence. It seemed likely that his successors would continue to rule in his image or, more worryingly, that far left groups would challenge a post-Franco autocrat. Yet, in the end, Franco failed spectacularly, and within three years of his death a new constitution had been enacted that put in place a democracy and enshrined liberal and progressive values. Meanwhile, Spain's regions, another issue detested by Franco, such as Catalonia and the Basque Country, secured significant autonomy within the new constitution. The conservative model installed by Franco, which lacked women's rights, linguistic recognition, or trade unions, was overturned.

Franco

Franco came to prominence during the years of David Lloyd George and Woodrow Wilson, yet he lived well into the era of Richard Nixon and Harold Wilson. Having joined the army when he was 15, by 1926 Franco had become the youngest general in Europe, and having survived the Spanish Civil War and World War II, he continued as dictator of Spain until his death in 1975.

Nietzsche's Enlightenment

The Nietzsche these works reveal is radically different from the popular image of him and even from the Nietzsche depicted in much of the secondary literature; they reveal a rational Nietzsche, one who preaches moderation instead of passionate excess and Dionysian frenzy. Franco concludes with a wideranging examination of Nietzsche's later works, tracking not only how his outlook changes from the middle period to the later but also how his commitment to reason and intellectual honesty in his middle works continues to inform his final writings.

Following Franco

The transition to democracy that followed the death of Spanish dictator Francisco Franco in 1975 was once hailed as a model of political transformation. But since the 2008 financial crisis it has come under intense scrutiny. Today, a growing divide exists between advocates of the Transition and those who see it as the source of Spain's current socio-political bankruptcy. This book revisits the crucial period from 1962 to 1992, exposing the networks of art, media and power that drove the Transition and continue to underpin Spanish politics in the present. Drawing on rare archival materials and over three hundred interviews with politicians, artists, journalists and ordinary Spaniards, including former prime minister Felipe Gonzalez (1982–96), Following Franco unlocks the complex and often contradictory narratives surrounding the foundation of contemporary Spain.

Franco-German Relations Seen from Abroad

This book examines external perceptions of the Franco-German relationship, both from a historical perspective and as a driving force for regional integration. By providing various country and regional studies, it analyses the various types of perception and self-perception in several regions around the globe. Here, Franco-German cooperation serves as a mirror in which third-party countries view their own situation, today and in the future. The contributions address the questions of if and how the Franco-German reconciliation

and cooperation is perceived as a role model for other regions, especially for the reconciliation of other interstate and international conflicts. A concluding chapter highlights the divergences and convergences between the respective conflicts, and proposes recommendations for actors involved in diplomacy and international relations. The book is intended to provide scientific support for the implementation of the Franco-German Aachen Treaty of January 2019. It will appeal to scholars in political science and cultural studies, and to anyone interested in learning more about the Franco-German relationship and on external perspectives on it.

THE SPANISH STORY FRANCO AND THE NATIONS AT WAR

Mauritian independence in 1968 marked the end of a regime favorable to the Franco-Mauritians, the island's white colonial elite. Now, in postcolonial Mauritius, this group is faced with a much more diverse power constellation and often feels in competition with others vying for their privileges. Though this is a clear departure from the colonial heydays, Franco-Mauritians have been able to continue their elite position into the early twenty-first century. This book focuses on the power of white elites still lingering on in postcolonial realities, and with regards to elites and power in general, addresses anew how an elite group aims to prolong its position over time.

The Franco-Mauritian Elite

At least 200,000 people died from hunger or malnutrition-related diseases in Spain during the 1940s. This book provides a political explanation for the famine and brings together a broad range of academics based in Spain, the United Kingdom, the United States and Australia to achieve this. Topics include the political causes of the famine, the physical and social consequences, the ways Spaniards tried to survive, the regime's reluctance to accept international relief, the politics of cooking at a time of famine, and the memory of the famine. The volume challenges the silence and misrepresentation that still surround the famine. It reveals the reality of how people perished in Spain because the Francoist authorities instituted a policy of food self-sufficiency (or autarky): a system of price regulation which placed restrictions on transport as well as food sales. The contributors trace the massive decline in food production which followed, the hoarding which took place on an enormous scale and the vast and deeply iniquitous black market that subsequently flourished at a time when salaries plunged to 50% below their levels in 1936: all contributing factors in the large-scale atrocity explored fully here for the first time.

Franco's Famine

This thought-provoking reexamination of the cultural artifacts of Francisco Franco's Spain looks at monuments, paintings, public works, novels, movies and computer games to present a new perspective on the events of the Spanish Civil War.

Franco's Crypt

Despite the repression, violence, and social hardship which characterised Spanish life in the 1940s and 1950s, the Franco regime sought to win popular support by promoting its apparent commitment to social justice. This study tells the story of the experts in public health, medicine, and social insurance sent to sell Franco's regime overseas.

Franco's Internationalists

Madrid became one of the key symbols of Republican resistance to General Franco during the Spanish Civil War following the Nationalists' failure to take the city in the winter of 1936-7. Yet despite the defiant cries of 'No pasarán', they did eventually pass on 28 March 1939. This book examines the consequences in Madrid of Franco's unconditional victory in the Spanish Civil War. Using recently available archival material, this study shows how the punishment of the vanquished was based on a cruel irony - Republicans, not the military rebels of July 1936, were held responsible for the fratricidal conflict. Military tribunals handed out sentences for the crime of 'military rebellion'; mere passivity towards the Nationalists before 1939 was not only made a civil offence under the Law of Political Responsibilities but could cause dismissal from work; and freemasons and Communists, specifically blamed for the Civil War, were criminalized by decree in March 1940. However, contrary to much that has been written on the subject, the post-war Francoist repression was not exterminatory. Genocide did not take place in post-war Madrid. While a minimum of 3113 judicial executions took place between 1939 and 1944, death sentences were largely based on accusations of participation in 'blood crimes' that occured in Madrid in 1936. Moreover, and unlike most other accounts of the Françoist political violence, this book is concerned with the question of when and why mass repression came to an end. It shows that the sheer numbers of cases opened against Republican 'rebels', and the use of complex pre-war bureaucratic procedures to process them, produced a crisis that was only resolved by decisions taken by the Franco regime in 1940-1 to abandon much of the repressive system. By 1944, mass repression had come to an end.

Franco's Justice

Rewriting Franco's Spain: Marcel Proust and the Dissident Novelists of Memory proposes a new reading of some of the most culturally significant and closely studied works of Spanish memory fiction from the past seventy years. It examines the influence of French writer Marcel Proust on fiction concerning the Spanish Civil War and Franco's dictatorship by Carmen Laforet, Juan Goytisolo, Juan Benet, Carmen Martín Gaite, Jorge Semprún, and Javier Marías. It explores the ways in which À la recherche du temps perdu has been instrumental in these authors' works, galvanizing their creative impetus, shaping their imaginative act, and guiding their adversarial stance toward Franco's regime. This book illustrates how these writers use Proustian themes and techniques and thereby enhances our understanding of the function of memory and fictional creation in some of the most important milestones in contemporary Spanish literature. Rewriting Franco's Spain argues that an appreciation of Proust's pervasive influence on Spanish memory writing obliges us to reconsider the notion that Franco's regime maintained a rigid stranglehold on imported culture. Capturing the richness of Spanish novelists' contact with literature produced outside of Spain, it challenges the prevailing scholarly tendency to focus on the novelists' immediate sociopolitical concerns. There is more to these texts than a simple testimony of the brutality and hardship of the civil war and life under Franco. By illuminating the subversive nature of Spanish novelists' use of a Proust-inspired practice of self-writing, Rewriting Franco's Spain seeks to readjust some of the ways we view the role of novelists living during the regime and in its wake. It advocates a conception of novelists as dissidents, teasing out the seditious undercurrent of their cultivation of self-writing and examining how they disputed the regime's ideas about what culture should look like. The preconception that the development of Spanish literature under Franco was stunted because Spaniards were prevented from reading works considered an affront to National-Catholic sensibilities is cast aside, as is the notion that Spain was isolated from narrative developments elsewhere. Rewriting Franco's Spain ultimately reveals the centrality of Proust's monumental novel in the evolution of contemporary Spanish literature.

Rewriting Franco's Spain

This is the first comprehensive study of the economic relationship between Nazi Germany and Franco's Spain between the outbreak of the Spanish Civil War and the end of the Second World War. It demonstrates how, during the Spanish Civil War, Hitler helped General Franco to victory, but at the same time attempted to turn Spain into an economic colony.

Economic Relations Between Nazi Germany and Franco's Spain

This book presents two systems of censorship and literary promotion, revealing how literature can be molded to support authoritarian regimes. The issue is complex in that at a descriptive level the strategies and methods new states use to control communication through the written word can be judged by how and when formal decrees were issued, and how publishing media, whether in the form of publishing companies or at the individual level, engaged with political overseers. But equally, literature was a means of resistance against an authoritarian regime, not only for writers but for readers as well. From the point of view of historical memory and intellectual history, stories of people without history and the production of their texts through the literary underground can be constructed from subsequent testimony: from books sold in secret, to the writings of women in jail, to books that were written but never published or distributed in any way, and to myriad compelling circumstances resulting from living under fascist authority. A parallel study on two fascist movements provides a unique viewpoint at literary, social and political levels. Comparative analysis of literary censorship/literary reward allows an understanding of the balance between dictatorship, official policy, and what literary acts were deemed acceptable. The regime need to control its population is revealed in the ways that a particular type of literature was encouraged; in the engagement of propoganda promotion; and in the setting up of institutions to gain international acceptance of the regime. The work is an important contribution to the history of twentieth-century authoritarianism and the development fascist ideas.

Literary Censorship in Francisco Franco's Spain and Getulio Vargas' Brazil, 1936-1945

Later in the war there were attacks by Italian surface warships, submarines, and aircraft against foreign shipping in the Mediterranean and Aegean leading to the British and French threatening pirate submarines. This is a story of exploitation, heroism, chauvinism, piracy, international inaction, and espionage which has never been told. It includes details of such things as the first aerial campaign against shipping and the first operational use of sonar against a submarine.

Rousseau, Nietzsche, and the Image of the Human

General Francisco Franco, also called the Caudillo, was the dictator of Spain from 1939 until his death in 1975. His life has been examined in many previous biographies. However, most of these have been traditional, linear biographies that focus on Franco's military and political careers, neglecting the significance of who exactly Franco was for the millions of Spaniards over whom he ruled for almost forty years. In this new biography Antonio Cazorla-Sanchez looks at Franco from a fresh perspective, emphasizing the cultural and social over the political. Cazorla-Sanchez's Franco uses previously unknown archival sources to analyse how the dictator was portrayed by the propaganda machine, how the opposition tried to undermine his prestige, and what kind of opinions, rumours and myths people formed of him, and how all these changed over time. The author argues that the collective construction of Franco's image emerged from a context of material needs, the political traumas caused by the Spanish Civil War (1936-1939), the complex cultural workings of a society in distress, political manipulation, and the lack of any meaningful public debate. Cazorla-Sanchez's Franco is a study of Franco's life as experienced and understood by ordinary people; by those who loved or admired him, by those who hated or disliked him, and more generally, by those who had no option but to accommodate their existence to his rule. The book has a significance that goes well beyond Spain, as Cazorla-Sanchez explores the all-too-common experience of what it is like to live under the deep shadow cast by an always officially praised, ever present, and long lasting dictator.
