Martin Bull and James Newell, renowned scholars of Italian Politics, argue that the early 1990s revolution in Italian party politics should be seen both as a major cause of subsequent changes in the political system and as a consequence of longer-term, still on-going changes in the Italian polity. The book explains how we can understand in this light the mixed success of the parties in attempting to act as autonomous vehicles of reform – and therefore why, if we are witnessing a transformation to a 'Second Republic', many of its key features still remain to be shaped. Each of the thematic chapters clearly juxtaposes Italy as it was before the 1990s with Italy today, thereby evaluating the degree to which the early 1990s can be seen as a watershed. In this way the book offers a novel account of both contemporary political developments and their historical significance in the context of the 'Italian political model' that took shape in the period after 1945. ## **The Italian Fascist Party in Power**

The Italian Fascist Party in Power was first published in 1959. Minnesota Archive Editions uses digital technology to make long-unavailable books once again accessible, and are published unaltered from the original University of Minnesota Press editions. Although much significant material on the Italian Fascist party became available when the regime collapsed, scholars have not made extensive use of it until now. In this study, which is based on all the available sources, Professor Germino describes the functions of the party, ,explains how it was organized to perform tasks, and discusses conflicts between the party and other power elements in the dictatorship. He reaches a conclusion contrary to that of most other scholars -- that Fascist Italy was a full-fledged totalitarian state resembling Nazi Germany and Soviet Russia in political structure and ideological content. ## **Confessions of an Interest Group**

Following World War II, the Catholic Church in Europe faced the challenge of establishing political influence with newly emerging democratic governments. The Church became, as Carolyn Warner pointedly argues, an interest group like any other, seeking to attain and solidify its influence by forming alliances with political parties. The author analyzes the Church's differing strategies in Italy, France, and Germany using microeconomic theories of the firm and historical institutionalism. She demonstrates how only a strategic perspective can explain the choice and longevity of the alliances in each case. In so doing, the author challenges earlier work that ignores the costs to interest groups and parties of sustaining or breaking their reciprocal links. Confessions of an Interest Group challenges the view of the Catholic Church as solely a moral force whose interests are seamlessly represented by the Christian Democratic parties. Blending theory, cultural narrative, and archival research, Warner demonstrates that the French Church's superficial and brief connection with a political party was directly related to its loss of political influence during the War. The Italian Church's power, on the other hand, remained stable through the War, so the Church and the Christian Democrats more easily found multiple grounds for long-term cooperation. The German Church chose yet another path, reluctantly aligning itself with a new Catholic-Protestant party. This book is an important work that expands the growing literature on the economics of religion, interest group behavior, and the politics of the Catholic Church.

By the spring of 1998, it had become clear that Italy, after considerable effort, had succeeded in bringing its public finances into line with the Maastricht parameters for joining the European Monetary Union. This was generally viewed as an important success of the Olive Tree coalition government led by Romano Prodi, and a sign that Italian political life had become "normal." Nevertheless, the Bicameral Commission, which should have fostered a radical constitutional reform with the aim to stabilize and strengthen the bipolar structure of the party system and the majoritarian functioning of democracy in Italy, was dismantled in June. Moreover, in October 1998 the Prodi government suddenly collapsed because of the internal opposition of the Neo-Communist wing of its parliamentary majority, a further demonstration that the Italian transition towards a more effective democratic rule is far from complete. Uncertainty about the future of the government and strong anti-political sentiment dominated Italian politics in 2007. Following a government crisis in February, rooted in the question of Italy's role in Afghanistan, Prime Minister Romano Prodi was able to re-establish his coalition, but in the spring it suffered a clear setback in local elections amidst a climate of growing unpopularity. ## **Frustrated Aspirations for Change**

When political parties make policy decisions they are influenced by the competition they face from other parties. Mixed-member electoral systems may well be the electoral reform of the 21st century, much as proportional representation (PR) was in the 20th century. In the view of many electoral reformers, mixed-member systems offer the best of both the traditional British single-seat district system and PR systems. This book seeks to evaluate: why mixed-member systems have recently appealed to many countries with diverse electoral histories; and how well expectations for these systems have been met. Each major country, which has adopted a mixed system thus, has two chapters in this book, one on origins and one on consequences. These countries are Germany, New Zealand, Italy, Israel, Japan, Venezuela, Bolivia, Mexico, Hungary, and Russia. In addition, there are also chapters on the prospects for a mixed-member system being adopted in Britain and Canada, respectively. The material presented suggests that mixed-member systems have been largely successful thus far. They appear to be more likely than most other electoral systems to generate two-bloc party systems, without in the process reducing minor parties to insignificance. In addition, they are more likely than any other class of electoral system to simultaneously generate local accountability as well as a nationally-oriented party system. Mixed-member electoral systems have now joined majoritarian and proportional systems as basic options which must be considered whenever electoral systems are designed or redesigned. Such a development represents a fundamental change in thinking about electoral systems around the world.

## **Mixed-Member Electoral Systems**

This book addresses the process of decentralization in Italy, examined from the perspective of political parties. In particular, it assesses whether and to what extent the dynamics of party competition are likely to shape policy agenda and affect policy change. The author starts by providing a thorough account of the process and history of Italian decentralization and the policy outcomes achieved over time, before discussing how party attention to an issue triggers related policy changes (manipulation of salience). Next, the focus shifts to the concrete positions adopted by parties on decentralization to assess whether the pattern of party competition has been consensual or adversarial, and how this pattern influenced the process of reform (manipulation of position). Finally, the author examines the role of frames in party competition. This volume offers essential research that will prove useful to a variety of audiences, ranging from scholars of territorial and Italian politics to those interested in agenda-setting, policy change, and party politics.

## **Area Handbook for Italy**

Electoral systems matter. They are a crucial link in the chain connecting the preferences of citizens to the policy choices made by governments. They are chosen by political actors and, once in existence, have political consequences for those actors. They are an important object of study for anyone interested in the political process, and in this book we subject them to systematic analysis. In addition to some comparative chapters, the book contains full accounts of the operation of electoral systems in 22 countries: France, the UK, Germany, Italy, Israel, Spain, Austria, Belgium, Denmark, Finland, The Netherlands, Ireland, Hungary, Russia, Australia, Canada, India, the USA, Japan, New Zealand, Chile, and South Africa. The book provides detailed analyses of the operation of a diverse set of electoral systems in their national context. Each chapter

explains how the electoral system really works in the given country, examining the strategic incentives the system provides to voters, candidates, and parties. All country chapters have a common format and structure. Successive sections analyse: the institutional context; how each electoral system was chosen historically; how the current electoral system operates (the rules, mechanics, and ballot structure); and the political consequences of the current system (the impact on the party system, the internal life of parties, and the impact on parliament and government formation). Each country chapter then contains a final section which focuses on the politicization of electoral institutions. In recent years many countries have changed their electoral systems, either entirely or in part so there is a strong focus on the processes of electoral reform, both historically and prospectively. The book concentrates on the real world 'politics', as well as the 'political science' of electoral systems. The book will be of interest to those concerned with the practical political business of electoral reform. The book contains a wealth of evidence about the performance of various kinds of proportional representation and of non-PR systems. This will be invaluable for anyone interested in the question: 'What would be the best electoral system for my country?'

## **Rosenthal's Common-sense Method of Practical Linguistics**

The question of whether Western party systems were becoming more unstable and electorates more volatile had already become central to the study of modern Europe by the end of the 1970s. Much of the literature at the time stressed how Western Europe was experiencing a phase of party breakdown, dealignment and decay, and how traditional mass politics was in the process of transformation. In this first book-length analysis of the subject, Stefano Bartolini and Peter Mair convincingly demonstrated how this emphasis on change had been largely misconceived and misplaced. This was the first systematic and conceptually sophisticated work to bring together the study of electoral change and cleavage persistence, and has since become one of the landmark volumes in the study of electoral politics in Europe. The authors examine patterns of electoral persistence and change in Western Europe between 1885 and 1985. They assess both what these patterns indicate with regard to the persistence of traditional cleavages, particularly the class cleavage, and how these patterns vary according to political, institutional and social factors. They analyse the various patterns of competition which have characterised elections across the different European countries and in different historical periods, and how cleavages can persist and re-emerge even in the face of widespread social change. They develop a sophisticated model of aggregate electoral change, in which national electorates are conceived as being torn between the stability brought about by cultural identities and organisational structures and the stimuli for change that are provoked by party competition and institutional change. *Identity, Competition and Electoral Availability* was awarded the Stein Rokkan Prize for Comparative Social Science Research and is now reprinted for the first time in paperback.

Peace support operations are one of the most important tools in the foreign policy of Western democracies. This book is a study of Italian military operations in the last twenty years. Italy's operations are examined through an analysis of parliamentary debates and interviews with leading policy-makers.

## **Dance, Human Rights, and Social Justice**

Ilaria Favretto presents a detailed study which traces the origins of the Third Way by comparing the European Left's contemporary neo-revisionism with past revisionist attempts. Focussing its analysis on the British Labour Party and the Italian Left, *The Long Search for a Third Way* provides new interpretations and insights into the histories of both parties. The book is accessible not only to students and scholars, but also to the general reader interested in contemporary European politics.

## **Apostles and Agitators**

It is difficult for Italians to have much faith in the future. The last Labour Minister said it was a good thing if young people emigrated, to stop them 'getting under our feet'; one recent Prime Minister said that young Italians should not invest their hopes in securing a stable job, for that would be 'boring', anyway. Examining Italy's history since the end of the Cold War, *Italy is the Future* argues that its dismal situation should not be understood in terms of a stereotyped narrative of Italian chaos or backwardness. In a country that could once boast Europe's strongest Left, Italy today epitomises the crisis of democracy in the West. The scandals of Silvio Berlusconi's rule, the pervasive corruption of public life and sky-high youth unemployment are indicators of a particularly sick society. Yet what is also apparent is the difficulty of any new force emerging to renew Italy's institutions, as its atomised citizens lose hope in political change. What has broken apart in Italy is not just its once-mighty Left but the very bases of social solidarity. The parties of the 1990s and 2000s directly express the social demolition wrought by neoliberalism, as isolated and endangered individuals face the consequences of the crisis alone. Not this or that political party, but public life itself, is in full-scale collapse
