Contro la crudeltà sugli animali

A critical biography of the early modern Italian naturalist. The Bolognese naturalist Ulisse Aldrovandi was a prolific writer, polymath, and prodigious collector who amassed the largest collection of naturalia in sixteenth-century Europe, as well as hundreds of colored drawings detailing them. Many of these drawings found their way into his illustrated publications, most of which were published posthumously. This book provides a concise yet comprehensive portrait of Aldrovandi, paying particular attention to two aspects: the role that the newly discovered continent of America played in his research interests, and his study of abnormalities of physiological development in organisms. Peter Mason gives insight into Aldrovandi's fascinating life, his early work on antiquities, his natural history and other collecting activities, his network of correspondents and patrons, and the influence and legacy of his collection and publications.

Ulisse Aldrovandi

This book provides an up-to-date survey of current issues and approaches in corpus linguistics in the form of twenty-two recent research articles. The articles cover a wide range of topics illustrating the diversity of research that is characteristic of corpus linguistics today. Central themes are the relationship between theory, intuition and corpus data and the role of corpora in linguistic research. The majority of the articles are empirical studies of specific aspects of English, ranging from lexis and grammar to discourse and pragmatics. Other areas explored are language variation, language change and development, language learning, cross-linguistic comparisons of English and other languages, and the development of linguistic software tools. The contributors to the volume include some of the leading figures in the field such as M.A.K. Halliday, John Sinclair, Geoffrey Leech and Michael Hoey. The theoretical and methodological issues addressed in the volume demonstrate clearly the steady advance of an expanding discipline inspired by an empirical, usage-based approach to the study of language. The volume is essential reading for researchers and students interested in the use of computer corpora in linguistic research.

Etica & Animali

The language of Latin veterinary medicine has never been systematically studied. This book seeks to elucidate the pathological and anatomical terminology of Latin veterinary treatises, and the general linguistic features of Pelagonius as a technical writer. Veterinary practice in antiquity cannot be related directly to that of the modern world. In antiquity a man could claim expertise in horse medicine without ever passing an examination. Owners often treated their own animals. The distinction between 'professional' and layman was thus blurred, and equally the distinction between 'scientific' terminology and laymen's terminology was not as clear-cut as it is today. The first part of the book is devoted to some of the non-linguistic factors which influenced the terminology in which horse diseases and their treatment were described.

Pelagonius and Latin Veterinary Terminology in the Roman Empire

Theophrastus was Aristotle's pupil and second head of the Peripatetic School. Apart from two botanical works, a collection of character sketches, and several scientific opuscula, his works survive only through quotations and reports in secondary sources. Recently these quotations and reports have been collected and published, thereby making the thought of Theophrastus accessible to a wide audience. The present volume contains seventeen responses to this material. There are chapters dealing with Theophrastus' views on logic, physics, biology, ethics, politics, rhetoric, and music, as well as the life of Theophrastus. Together these writings throw considerable light on fundamental questions concerning the development and importance of the Peripatos in the early Hellenistic period. The authors consider whether Theophrastus was a systematic

thinker who imposed coherence and consistency on a growing body of knowledge, or a problem-oriented thinker who foreshadowed the dissolution of Peripatetic thought into various loosely connected disciplines. Of special interest are those essays which deal with Theophrastus' intellectual position in relation to the lively philosophic scene occupied by such contemporaries as Zeno, the founder of the Stoa, and Epicurus, the founder of the Garden, as well as Xenocrates and Polemon of the Academy, and Theophrastus' fellow Peripatetics, Eudemus and Strato. He took as the basis for his work the translation from the Arabic made in Toledo around 1220 by Michael Scotus which included three important Aristotelian treatises. Preceding the critical edition, Dr Navarro offers an introduction to the person and works of Peter of Spain, the intellectual context of the 13th century characterized by Scholasticism and an Aristotelian Renaissance, and a short analysis of the linguistics and form of the *Questiones*. She also analyses the sources on which Peter drew, Greco-Latin, Arabo-Jewish and, of course, late antique and medieval treatises, showing that the text was not exclusively zoological in nature, but discusses important medical and philosophical topics, illustrating his extensive knowledge of both the Aristotelian corpus and 13th-century medicine. The text (divided into XIX books) is not a mere commentary about animals, but rather, as the title shows, a collection of questions in the Salernitan manner, the use of which was considered most appropriate for analysis and communication in the medieval scientific community to which Peter of Spain belonged. Alongside methodological and zoological problems, Peter of Spain discusses important questions disputed among the scholars of the period, including the location, hierarchy, motion, function and parts of the principal organs, the five senses, and many other medical issues such as reproduction, illnesses, or growth. Finally Dr Navarro includes a glossary that contains proper names (mainly those of the authorities and sources quoted by Petrus Hispanus), animal names (and their parts and substances), and the names of plants, metals, and the like.
