## Introducing Syntax

This lively textbook introduces readers to the formal theory of syntax, presenting contemporary insights without unnecessary technical detail.

## A Syntax of Substance

A new approach to grammar and meaning of relational nouns is presented along with its empirical consequences. In *A Syntax of Substance*, David Adger proposes a new approach to phrase structure that eschews functional heads and labels structures exocentrically. His proposal simultaneously simplifies the syntactic system and restricts the range of possible structures, ruling out the ubiquitous (remnant) roll-up derivations and forcing a separation of arguments from their apparent heads. This new system has a number of empirical consequences, which Adger explores in the domain of relational nominals across different language families, including Germanic, Romance, Celtic, Polynesian, and Semitic. He shows that the relationality of such nouns as *hand*, *edge*, or *mother*—which seem to have as part of their meaning a relation between substances—is actually part of the syntactic representation in which they are used rather than an inherent part of their meaning. This empirical outcome follows directly from the new syntactic system, as does a novel analysis of PP complements to nouns and possessors. Given this, he argues that nouns can, in general, be thought of as simply specifications of substance, differentiating them from true predicates. *A Syntax of Substance* offers an innovative contribution to debates in theoretical syntax about the nature of syntactic representations and how they connect to semantic interpretation and linear order.

## Word Meaning and Syntax

This book examines the nature of the interface between word meaning and syntax, one of the most controversial and elusive issues in contemporary linguistics. It approaches the interface from both sides of the relation, and surveys a range of views on the mapping between them, with an emphasis on lexical approaches to argument structure. Stephen Wechsler begins by analysing the fundamental problem of word meaning, with discussions of vagueness and polysemy, complemented with a look at the roles of world knowledge and normative aspects of word meaning. He then surveys the argument-taking properties of verbs and other predicators, and presents key theories of lexical semantic structure. Later chapters provide a description of formal theories and frameworks for capturing the mapping from word meaning to syntactic structure, as well as arguments in favour of a lexicalist approach to argument structure. The book will interest scholars of theoretical linguistics, particularly in the fields of syntax and lexical semantics, as well as those interested in psycholinguistics and philosophy of language.

## Modern Syntax

This book presents a cross-section of recent generative research into the syntax of relative clauses constructions. Most of the papers collected here react in some way to Kayne's (1994) proposal to handle relative clauses in terms of determiner complementation and raising of the relativized nominal. ## **The Syntax of Relative Clauses**

## **Elements of Structural Syntax**

This book explores the interaction of grammar and context in human communication. Lutz Marten focuses on verbs and verb phrases: he examines the relationship between language rules and linguistic behaviour, seeking to distinguish between language-specific syntactic knowledge and the general reasoning people need to understand and to make themselves understood. He considers how the component elements of linguistic theory explain what appear to be simple utterances but whose structure is hard to analyse - how, for example, 'Fran is baking Mary a cake in the oven' is different from 'Fran is baking Mary a cake in the kitchen'. The author's account of the interactions of syntax, semantics, and pragmatics is based on extensive observation among contrasting cultures and a variety of languages. He makes important contributions to understanding in all three areas. His book will appeal to linguistic theoreticians of all persuasions.

## **At the Syntax-pragmatics Interface**

In this book, Ljiljana Progovac proposes a gradualist, adaptationist approach to the evolution of syntax, subject to natural selection. As a result, this reconstruction can be meaningfully correlated with both the hominin timeline and the ever-growing body of genetic evidence that is available.

## **Evolutionary Syntax**

Even though the range of phenomena syntactic theories intend to account for is basically the same, the large number of current approaches to syntax shows how differently these phenomena can be interpreted, described, and explained. The goal of the volume is to probe into the question of how exactly these frameworks differ and what if anything they have in common. Descriptions of a sample of current approaches to syntax are presented by their major practitioners (Part I) followed by their metatheoretical underpinnings (Part II). Given that the goal is to facilitate a systematic comparison among the approaches, a checklist of issues was given to the contributors to address. The main headings are Data, Goals, Descriptive

Tools, and Criteria for Evaluation. The chapters are structured uniformly allowing an item-by-item survey across the frameworks. The introduction lays out the parameters along which syntactic frameworks must be the same and how they may differ and a final paper draws some conclusions about similarities and differences. The volume is of interest to descriptive linguists, theoreticians of grammar, philosophers of science, and studies of the cognitive science of science.

## **The Cambridge Handbook of Experimental Syntax**

This volume offers a new perspective on the syntax of nominal expressions in various European languages, arguing that articles do not directly and biunivocally realise semantic definiteness. The first two chapters provide an accessible introduction to recent developments in generative syntax, namely the cartographic and minimalist approaches, by focusing on the “imperfect” parallels between clauses and nominal expressions. The third chapter shows that feature sharing is not the result of a unique syntactic process, but, rather, the consequence of Merge, which creates syntactic structure instantiating two types of relation: Selection and Modification. It argues for three different ways of transferring features: Agreement allows for an argument (an independent phase, selected by a head) to re-enter the computation as part of the predicate of the new phase. It targets Person features and is not involved in the feature sharing triggered by modification. Concord copies the features of N (notably gender, number and case, where this is present). It is the result of Modification and can coexist with Agreement. Finally, Projection is triggered by multiple internal mergers of the head, bundled with all its interpretable and uninterpretable features, which may be realized in different segments. The fourth chapter focuses on the nature of determiners such as articles, demonstratives, quantifiers, possessive adjectives and pronouns, personal pronouns and proper names, and shows that only articles have the properties to be attributed to “functional heads” because they are a segment of a scattered nominal head. The rest of the volume is devoted to the analysis of syntactic phenomena, such as double definiteness, expletive articles, and weak and strong adjectival inflection, by means of the proposal that (scattered) nominal or adjectival heads concord with their modifiers. This approach reinterprets head movement in a fashion that makes it compatible with minimalist requirements, provides an explanation for the apparent optionality of head movement, eliminates the typology of head movements by adjunction or substitution, and gives an original answer to the doubts raised about the legitimacy of the very notion of “functional category”.

## **Nominal Syntax at the Interfaces**

This book investigates the way grammar deals with the representation of aspectual (aktionsart) concepts, focussing on issues of the lexicon-syntax interface. The authors' innovative analyses of this interface significantly advance our understanding of the role that syntax plays in determining verbal meaning, aspectual interpretation, and thematic information. Various theories are developed in this collection, including those that take as their starting point the lexical-syntactic framework of Hale and Keyser, prominent among which is the chapter by Hale and Keyser themselves. By examining different phenomena in a cross-linguistic perspective, this book develops insights into the general theoretical question of universal grammar and acquisition as well as into the specific nature of the lexicon-syntax interface. It is a major contribution to modern syntactic theory.

## **The Syntax of Aspect**

Human language seems to have arisen roughly within the last 50-100,000 years. In evolutionary terms, this is the mere blink of an eye. If this is correct, then much of what we consider distinctive to language must in fact

involve operations available in pre-linguistic cognitive domains. In this book Norbert Hornstein, one of the most influential linguists working on syntax, discusses a topical set of issues in syntactic theory, including a number of original proposals at the cutting edge of research in this area. He provides a theory of the basic grammatical operations and suggests that there is only one that is distinctive to language. If this theory is correct then this narrows the evolutionary gap between verbal and non-verbal primates, thus facilitating the rapid evolutionary emergence of our linguistic capacity.

## **A Theory of Syntax**

## **English Syntax, second edition**

This work focuses on diverse aspects of complex predicate phenomena, including order variation, constituency relations, interactions with other construction types, argument relations, and the syntax morphology interface.

## **Complex Predicates in Nonderivational Syntax**

Morphosyntax of Verb Movement discusses the phenomenon of Dutch, present in many Germanic languages, that the finite verb is fronted in main clauses but not in embedded clauses. The theoretical framework adopted is the so-called Minimalist Program of Chomsky (1995), the latest developmental stage of generative grammar. Taking issue with previous analyses, the author argues that phrase structure in Dutch is uniformly head initial, and that the finite verb moves to different positions in subject initial main clauses and in inversion constructions. The book contains lucid and detailed discussion of many theoretical issues in connection with the Minimalist Program, such as the relation between syntax and morphology, the nature of syntactic licensing, and the structure of the functional domain. At the same time, it offers a survey of the properties of Dutch syntax, a discussion of previous analyses of Dutch syntax and a wealth of material from dialects of Dutch and other Germanic languages.

## **Morphosyntax of Verb Movement**

This collection of essays grew out of the workshop 'Existence: Semantics and Syntax', which was held at the University of Nancy 2 in September 2002. types of linguistic constructions: copular clauses, existential sentences, and (in)definite noun phrases.

## **Existence: Semantics and Syntax**

A new theory of syntactic movement within a Chomskyan framework. Chomsky showed that no description of natural language syntax would be adequate without some notion of movement operations in a syntactic derivation. It now seems likely that such movement transformations are formally simple operations, in which a single phrase is displaced from its original position within a phrase marker, but after more than fifty years of generative theorizing, the mechanics of syntactic movement are still murky and controversial. In *Provocative Syntax*, Phil Branigan examines the forces that drive syntactic movement and offers a new synthetic model of the basic movement operation by reassembling in a novel way isolated ideas that have been suggested elsewhere in the literature. The unifying concept is the operation of provocation, which occurs in the course of feature valuation when certain probes seek a value for their unvalued features by identifying a goal. Provocation forces the generation of a copy of the goal; the copy originates outside the original phrase marker and must then be introduced into it. In this approach, movement is not forced by the need for extra positions; extra positions are generated because movement is taking place. After presenting the central proposal and showing its implementation in the analyses of various familiar cases of syntactic movement, Branigan demonstrates the effects of provocation in a variety of inversion constructions, examines interactions between head and phrasal provocation within the "left periphery" of Germanic embedded clauses, and describes the details of chain formation and successive cyclic movement in a provocation model.

## **Provocative Syntax**

Coordination in syntax is an important part of the analysis of sentence structure. Niina Ning Zhang addresses the issues raised by coordinate pairings and the implications of these structures, looking in particular at examples within English and Chinese. The volume covers the major questions regarding coordinates in syntax, providing a fresh perspective to arguments raised within previous literature. She explains how such coordinate complexes are structured, how some coordinators can be combined in parts of speech, the fixed nature of some of these pairings and what changes exist between the coordinate and non-coordinate constructions. The theories raised are backed up by a rich variety of examples as well as providing a cross-linguistic perspective, contextualising these ideas within current syntactic research.

## **Coordination in Syntax**

Assuming no prior knowledge, *Understanding Syntax* illustrates the major concepts, categories and terminology associated with the study of cross-linguistic syntax. A theory-neutral and descriptive viewpoint is taken throughout. Starting with an overview of what syntax is, the book moves on to an explanation of word classes (such as noun, verb, adjective) and then to a discussion of sentence structure in the world's languages. Grammatical constructions and relationships between words in a clause are explained and thoroughly illustrated, including grammatical relations such as subject and object; function-changing processes such as the passive and antipassive; case and agreement processes, including both ergative and accusative alignments; verb serialization; head-marking and dependent-marking grammars; configurational and non-configurational languages; questions and relative clauses. The final chapter explains and illustrates the principles involved in writing a brief syntactic sketch of a language, enabling the reader to construct a grammatical sketch of a language known to them. Data from approximately 100 languages appears in the text, with languages representing widely differing geographical areas and distinct language families. The book will be essential for courses in cross-linguistic syntax, language typology, and linguistic fieldwork, as well as for basic syntactic description.

## **Understanding Syntax**



Research on the interplay between language structure and language use has shown that grammar is shaped, maintained, and modified by language use. In this view, then, grammar is not seen as existing apart from language use, but rather as a set of recurrent, grammaticized patterns of discourse. This book focuses on syntactic structuring in Finnish from the viewpoint of language use. The author sets out to study syntactic structures in their local contexts in order to discover the more global patterns and constraints on the use of these structures. The coding strategies point to the clause core as the locus of syntactic structuring: this is where syntactic relations emerge most clearly. It is shown that the key to understanding the coding of the core syntactic relations is the category of person. The clause core also shows strong intonational unity as it is most often presented in one intonation unit. Furthermore, analysis of spoken discourse shows the robustness of the category of noun phrase, both as a clausal constituent and as a free syntactic unit, the free NP.

## **Syntax in the Making**

Until recently, little attention has been paid within syntax to components of discourse meaning that go beyond information structure and fall into the domain of non-at-issue meaning operating at the level of illocutionary force. To approach this domain, many of the contributions of this volume deal with the syntax of discourse particles. However, the issue of how to account for discourse particles within a more explicit map of the illocutionary domain is a good starting point for considering further phenomena related to the syntax of speech acts. By focusing on speech-act related particles and/or meaning domains, this volume makes a new contribution to the field, as existing collections either do not offer a comparatively narrow focus on particles or are not limited to syntax-oriented approaches. The primary audience of this volume are researchers and graduate students interested in state-of-the-art approaches to the syntax-discourse interface within the cartographic approach to syntax.

## **Discourse-oriented Syntax**

*Syntax: Basic Concepts and Applications* provides a systematic introduction to core topics in syntax, focusing on how the basic concepts apply in the analysis of sentences. Assuming no background in linguistic analysis, the book gives students a working knowledge of syntactic analysis from a minimalist perspective. Step by step it explains the fundamentals of phrase structure, movement and deletion. Well-placed exercises throughout reinforce and extend the concepts and analyses presented in the text, allowing readers to gain understanding of progressively complex issues at a comfortable pace. Much of the data comes from English, but crucial examples are also drawn from a range of other languages, including Russian, Chinese, Japanese, French, Italian, Spanish, Irish, Welsh and Greek.

## **Syntax**

Change is an inherent feature of all aspects of language, and syntax is no exception. While the synchronic study of syntax allows us to make discoveries about the nature of syntactic structure, the study of historical syntax offers even greater possibilities. Over recent decades, the study of historical syntax has proven to be a powerful scientific tool of enquiry with which to challenge and reassess hypotheses and ideas about the nature of syntactic structure which go beyond the observed limits of the study of the synchronic syntax of individual languages or language families. ## **An Introduction to English Syntax**

*Lexical-Functional Syntax* is the definitive text for Lexical-Functional Grammar in the field of syntax. ## **Lexical-Functional Syntax**

This book analyses the development of a number of English and French constructions involving various kinds of subject-verb inversion. The analysis is framed in terms of the principles-and-parameters approach to syntactic theory, and provides strong support for the adoption of this approach in the description and explanation of language change. The book falls into three parts. The first presents an overall framework for the analysis of inversion constructions and motivates, on the basis of synchronic data, several parameters which distinguish among the various Romance and Germanic languages. The second part shows how several near-simultaneous syntactic changes in the history of French can be explained as a change in one of the parameters introduced in Chapter One. A notable aspect of this analysis is the way in which the distribution of null subjects is shown to relate to verb-placement. The third part of the book treats verb-movement in the history of English, arguing in detail that the attested changes in this area are due to a change in the internal structure of 'Infl', a proposal which has important ramifications for the theory of functional heads. Throughout the book, emphasis is placed on the theoretical questions raised by language change. In this connection the two notions of diachronic reanalysis and parametric change are distinguished. Verbs and Diachronic Syntax will interest all theoretical linguists as well as specialists in the history of English, history of French, Germanic philology and Romance philology.

## **Verbs and Diachronic Syntax**

The architecture of the human language faculty has been one of the main foci of the linguistic research of the last half century. This branch of linguistics, broadly known as Generative Grammar, is concerned with the

formulation of explanatory formal accounts of linguistic phenomena with the ulterior goal of gaining insight into the properties of the 'language organ'. The series comprises high quality monographs and collected volumes that address such issues.
