## **Last Victim**

*Criminals and Victims* presents an economic analysis of decisions made by criminals and victims of crime before, during, and after a crime or victimization occurs. Its main purpose is to illustrate how the application of analytical tools from economics can help us to understand the causes and consequences of criminal and victim choices, aiding efforts to deter or reduce the consequences of crime. By examining these decisions along a logical timeline over which crimes take place, we can begin to think more clearly about how policy effects change when it is targeted at specific decisions within the body of a crime. This book differs from others by recognizing the timeline of a crime, paying particular attention to victim decisions, and examining each step in the crime cycle at the micro-level. It demonstrates that criminals plan their crimes in systematic, economically logical ways; that deterring the destruction of criminal evidence may deter crime in general; and that white-collar criminals exhibit recidivism patterns not unlike those of street criminals. It further shows that the degree of criminality in a society motivates a variety of self-protection behaviors by potential victims; that not all victim resistance makes matters worse (and some may help); and that victims who report their crimes do not receive high returns for going to the police, helping to explain why some crimes ultimately go unreported.

## **From Crime Policy to Victim Policy**

Prior to the emergence of a victims' movement in this country in the 1970s, crime victims had only limited formal rights and remedies in the modern American criminal justice system. With the active encouragement of those involved in the victims' movement and guidance supplied by a national Task Force on Victims of Crime, convened by President Reagan in 1982, federal and state authorization of crime victim rights and remedies has increased exponentially in the subsequent years. In fact, it has been estimated that there are currently tens of thousands of statutes that directly or indirectly affect crime victim rights and interests, as well as crime victim-related constitutional provisions in a majority of states. The authors describe the constitutional and legislative provisions addressing the principal crime victim rights and remedies and leading judicial opinions that have interpreted them. In addition to presenting the current state of the law in this area, the text describes the status of implementation of these rights and remedies, relevant empirical research, and a sampling of pertinent policy analysis. This comprehensive portrait of the past and current status of crime victim rights and remedies in this country will inform the continued evolution of law and practice in this area. The third edition of *Crime Victim Rights and Remedies* continues to address the evolution of key crime victim rights (e.g., the rights to notice of and to be present and heard at criminal justice proceedings) and includes the state constitutional amendments, legislation, court decisions, and empirical studies completed since the second edition in 2010. Of particular note is an expanded federal section regarding each right and remedy in the federal Crime Victims' Rights Act, enacted in 2004, and court decisions that have interpreted the Act in its initial decade of implementation. The third edition also adds a new chapter concerning crime victim rights and remedies in the United States armed services and internationally.

## **I Am Not Your Victim**

Victims of the Book uncovers a long-neglected but once widespread subgenre: the fin-de-siècle novel of formation in France. In the final decades of the nineteenth century, social commentators insistently characterized excessive reading as an emasculating illness that afflicted French youth. Novels about and geared toward adolescent male readers were imbued with a deep worry over young Frenchmen's masculinity, as evidenced by titles like *Crise de jeunesse* (Youth in Crisis, 1897), *La Crise virile* (Crisis of Virility, 1898), *La Vie stérile* (A Sterile Life, 1892), and *La Mortelle Impuissance* (Deadly Impotence, 1903). In this book, François Proulx examines a wide panorama of these novels, as well as polemical essays, pedagogical articles, and medical treatises on the perceived threats posed by young Frenchmen's reading habits. Fin-de-siècle writers responded to this pathologization of reading with a profusion of novels addressed to young male readers, paradoxically proposing their own novels as potential cures. In the early twentieth century, this corpus was critically revisited by a new generation of writers. *Victims of the Book* shows how André Gide and Marcel Proust in particular reworked the fin-de-siècle paradox to subvert cultural norms about literature and masculinity, proposing instead a queer pact between writer and reader.

## **Victims and Victimhood**

When the victims of injustice lose faith in their justice system, the crime they've endured cuts only deeper, adding insult to injury. The time has come to face the truth that most victims of crime will not have their needs met and often won't experience our systems of justice as just. Despite the speeches and the United Nations norms, governments still leave most victims of crime without basic information, support, and assistance, let alone respect and remedies in courts. If you are not yet one of those victims of crime, social responsibility requires you to ensure that your country's systems of justice are fair to those who are and for them, this book provides an answer.

## **The Wrong Victim**

Each year, in a solemn Sunni Muslim feast, the Ait Mizane of southern Morocco reenact the story of Abraham as a ritual sacrifice, a symbolic observance of their submission to the divine. After this sober ceremony comes a bacchanalian masquerade which seems to violate every principle the sacrifice affirmed. Because of the apparent contradiction between sacrifice and masquerade, observers have described the two as entirely separate events. ## **Victims of the Book**

This book provides a fascinating look at the creation of contemporary Muslim jihadists. Basing the book on her long-term fieldwork in the disputed borderlands between Pakistan and India, Cabeiri deBergh Robinson tells the stories of people whose lives and families have been shaped by a long history of political conflict. Interweaving historical and ethnographic evidence, Robinson explains how refuge-seeking has become a socially and politically debased practice in the Kashmir region and why this devaluation has turned refugee men into potential militants. She reveals the fraught social processes by which individuals and families produce and maintain a modern jihad, and she shows how Muslim refugees have forged an Islamic notion of rights—a hybrid of global political ideals that adopts the language of human rights and humanitarianism as a means to rethink refugees' positions in transnational communities. Jihad is no longer seen as a collective fight for the sovereignty of the Islamic polity, but instead as a personal struggle to establish the security of Muslim bodies against political violence, torture, and rape. Robinson describes how this new understanding has contributed to the popularization of jihad in the Kashmir region, decentered religious institutions as regulators of jihad in practice, and turned the families of refugee youths into the ultimate mediators of entrance into militant organizations. This provocative book challenges the idea that extremism in modern Muslim societies is the natural by-product of a clash of civilizations, of a universal Islamist ideology, or of fundamentalist conversion.

## **The Victim**

*Moral Wages* offers the reader a vivid depiction of what it is like to work inside an agency that assists victims of domestic violence and sexual assault. Based on over a year of fieldwork by a man in a setting many presume to be hostile to men, this ethnographic account is unlike most research on the topic of violence against women. Instead of focusing on the victims or perpetrators of abuse, *Moral Wages* focuses exclusively on the service providers in the middle. It shows how victim advocates and counselors—who don't enjoy extrinsic benefits like pay, power, and prestige—are sustained by a different kind of compensation. As long as they can overcome a number of workplace dilemmas, they earn a special type of emotional reward reserved for those who help others in need: moral wages. As their struggles mount, though, it becomes clear that their jobs often put them in impossible situations—requiring them to aid and feel for vulnerable clients, yet giving them few and feeble tools to combat a persistent social problem.

## **Rights for Victims of Crime**

The world is peopled by victims; everyone has a story. However, victimhood is just the beginning of the story. This book is about the endings of at least some of those stories, the stories of victims who strive to overcome and even triumph in the end. This book is a collection of research perspectives and personal stories exploring the various pathways for overcoming victimhood. It is hoped that they might offer an inspiration for others and encourage others to stay on the path to find a positive ending. *Victim Victorious* is an examination of the ways in which victims come to rise above the challenges that they face. Victims may be innocent bystanders, and in no way responsible for their victimhood. Nonetheless, they can -- and indeed we argue need to -- take responsibility for finding a personal solution. To assist in this task, this book chronicles the pathway of prejudice and how the pain and the damage experienced by individual victims may be overcome by effort, by and on their own behalf. The first half of the book features outsider views of victimhood. A range of professionals, philosophers, psychologists, criminologists and critical theorists offer their thoughts on how people might overcome victimhood. The second half of the book features insider views of victimhood; in this section, the victims speak for themselves about their experience and how they have endeavoured to break through their victimhood. This book is less about identifying and proscribing the behaviours of perpetrators and more about the efforts that victims can undertake to heal themselves as they journey towards resilience and victory.

## **The Victim and Its Masks**

This book is a guide to the law and practice of victims' roles before the International Criminal Court, the Extraordinary Chambers in the Courts of Cambodia and the Special Tribunal for Lebanon. The various chapters focus on the provisions relevant to victim participation at these courts and the case law interpreting and applying those provisions. The book thus informs the reader on the principal ways in which the relevant practice is developing, the distinct avenues taken in the application of similar provisions as well as the ensuing advantages and challenges. Unlike other volumes focusing on relevant academic literature, this volume is written mainly by practitioners and is addressed to those lawyers, legal advisers and victimologists who work or wish to work in the field of victim participation in international criminal justice. Kinga Tibori-Szabó is legal officer for the Kosovo Specialist Chambers in The Hague and has previously worked for the Legal Representative of Victims at the Special Tribunal for Lebanon. Megan Hirst is a barrister at Doughty Street Chambers in London and has worked on victims' participation issues in the Registries of the International Criminal Court and the Special Tribunal for Lebanon, as well as in an LRV team in *Prosecutor v. Dominic Ongwen*.

## **Moral Wages**

This book focuses beyond the bully-victim dyad to highlight how bullying commonly unfolds within a complex system that involves many individuals interacting with one another. As the vast majority of bullying episodes occur in front of a peer audience, this book examines the ways in which bystanders can act to either fuel or deter bullying. Each chapter highlights a particular participant role: bully, assistant, reinforcer, outsider, defender, and victim. Attention is also devoted to the important influence parents and teachers have on the peer ecology and bullying dynamics. By viewing bullying through the eyes of each individual role, the authors provide an in-depth exploration of bullying as a group process with special attention to implications for prevention and intervention. This book refreshes and expands our understanding of bullying as a group process by highlighting classic research while integrating new findings with attention to changing technology and the modernization of our society. ## **Victim Participation in International Criminal Justice**

Recent years have seen a heightened awareness of the plight of victims of crime and their neglect by the traditional criminal justice system. Many jurisdictions have adopted a "Bill of Rights" for the victim; public funds have been established to compensate victims; courts have been enjoined to order offenders to make restitution; welfare agencies have developed programs to provide victims with assistance; and courts are inviting victims to testify at the sentencing hearings of their offenders. These reforms have been accompanied by a growing body of literature. What has been lacking until now is an overview that looks at their philosophical underpinnings and considers how these different proposals are conceptually related to one another and to other prevailing criminal justice doctrines and ideologies. Leslie Sebba fills this gap in *Third Parties*. Sebba first establishes a set of criteria by which to evaluate reforms by identifying the parameters of an optimal criminal justice system. From this perspective, he then discusses individual victim-related reforms. What emerges most clearly from Sebba's timely and encyclopedic work is the need to rethink many of the issues involved. The first book-length study of its kind, this volume is recommended reading for policy makers in the field of victim reform and is essential for scholars and students in victimology, victims and the criminal justice system, the sociology of law, criminal justice policy, and law and social policy. Leslie Sebba is professor of criminology on the faculty of law at the Hebrew University of Jerusalem. He is the coauthor of "Rehabilitation as Punishment: The Treatment of Drug-Addict Offenders" and "Punishment under the "Service Work" Law: An Evaluation" and the co-editor of "Criminology in Perspective: Essays in Honor of Israel Drapkin." He is one of the founding editors of "The International Review of Victimology."

## **Victims in the Criminal Justice System**

This book critically exposes some of the factors used in the risk determination of intimate partner violence, alongside an analysis on the definition and management of the risk of recidivism. Traditional beliefs and gender stereotypes underlying police attitudes associated with domestic violence are explored. The authors provide considerations for domestic violence prevention and intervention programs, highlighting the importance of adopting proactive and supportive attitudes in response to victims. Researchers have measured intimate partner violence and survivors' help-seeking through a variety of different instruments, making it difficult to paint a consistent picture of intimate partner violence. As such, this collection includes the results of a study comparing three measures so as to examine whether a certain measure produces a discernible pattern of results. A subsequent study analyses the relationship between psychopathological symptomatology and intimate partner violence in a sample of 122 Portuguese women participants, 61 with a judiciary victim



status and 61 without this status. To avoid discrepancies between medical reporting and the reconstruction of sex crimes, it is crucial to use strategies which focus not only on technical aspects of evidence collection, but also on the way the victim's story will be recorded. Women most commonly experience violence victimisation by someone close to them. Therapeutic work with victims/survivors of intimate partner violence may range from immediate crisis intervention to long-term support. The award-winning PAWS FOR EMPOWERMENT program in Pittsburgh, Pennsylvania is discussed, as well as the successes and challenges the program has faced in rescuing and training shelter dogs to serve as canine advocates. A qualitative study is presented which aims to further our understanding of how domestic violence between intimate partners can affect maternal parenting. The sample used comprised 15 mothers and victims of domestic violence, focusing on understanding how they conceive of their role as a parent. The authors go on to explore the extent to which domestic violence is regulated in Indonesia, and the extent to which such regulation is implemented. This compilation also examines how the practice of forced marriage arrangements creates vulnerabilities for girls and young women. Accordingly, a discussion is provided concerning differences and similarities between the concepts of arranged and forced marriage, and its relationship to sexual trafficking. The authors summarize findings on the association between cyber dating abuse and offline dating violence in a sample of 145 Portuguese adolescents and young adults. Additionally, a review of the literature on the phenomenon of multiple child and youth victimization is carried out, addressing the main risk factors, the implications for the development of children and young people, and guidelines for intervention. The impact that community violence exposure has on youth is assessed, accompanied with practical proposals for prevention. The concept of community violence and the different types of violence and crimes that could be involved are examined, mapping the prevalence of youth affected by this type of violence. Accordingly, to develop appropriate helpful responses to victims of violence and crime, it is particularly relevant to assess people's perceptions, to be aware of their victimization experiences and to identify their needs. In closing, using Saint Lucia as an example, some of the challenges of supporting victims of intimate violence on an island are illustrated, discussing innovative policies and practices to best support victims in this context.

## **Blaming the Victim**

An examination of the psychological literature on victimisation shows disproportionately that that we know more about the predator than we do the victim. Moreover, almost all the literature on the victim is presented from either a reductionistic or cognitive-behavioural point of view. This book examines the psychology of a victim of repeated criminal acts from the existential-humanistic perspective. The method used is the single case study. The subject, currently age 51, a pilot, was the victim of identity theft, extortion, and duress. These crimes, some of which are treated under federal law as violent by their nature or effect, resulted in a large, unrecoverable financial loss, suspension of the pilot's medical certification required to operate aircraft, abrupt termination of his chosen career, a continuing governmental record of being delusional despite overwhelming proof to the contrary, lasting emotional and physical distress, as well as other consequences. Meanwhile, the predator has harmed dozens of individuals, forming a diverse cohort. A life history of the subject is presented as a context for the specific chronology of events defining his victimisation, which is followed by an existential interpretation. Interviews and archival data, including written and audio forms of documentation, have been incorporated into the study. Seven criteria were selected from existential-humanistic psychology that have been applied in the exploration of the behaviour and personality of the victim: (1) the interior life-world of the person; (2) self-actualisation needs vs. adjustment to social norms; (3) meaning through suffering; (4) being in the face of non-being; (5) attitudes toward death and annihilation; (6) dreams, visions, and mythic experience; and (7) existential use of the void. The study found characteristics of the psyche of a particular victim that may have made him vulnerable. These characteristics include: being overly trusting; being under the influence of a hero-rescuer archetype; and being overly reliant on instruments due to training as a pilot. Mainstream psychology has ignored this dimension, which is needed to understand the total person.

## **Bullies, Victims, and Bystanders**

This book employs principles of therapeutic jurisprudence (TJ) to examine how various countries approach victim participation in criminal justice proceedings. It collects papers from a conference in Onati, Spain, that was supported by a grant from the Transcoop Programme of the Alexander Von Humboldt Foundation to study the potential impact of TJ approaches on victims. The Onati conference broke important ground by addressing victim welfare and well-being during and after participation in criminal justice proceedings and brought scholars from different disciplines and nations together to share their ideas. The resulting collection brings these ideas to a wider audience in the fields of law, legal studies, sociology, psychology and criminology/victimology. The contributors are recognized researchers in their home countries and the collection provides yet another critical and empirical research contribution from a TJ perspective.
