F.W. Maitland is sometimes thought of as merely a great legal historian of England. Yet in over three thousand published pages, including his History of English Law (1895) with F. Pollock (of which Maitland wrote all but one chapter), his Collected Papers in three volumes (1911), The Constitutional History of England (1919) and many other works he reveals himself to be one of the profoundest thinkers on how our modern world emerged, on a level with Montesquieu and Tocqueville. Maitland's works on Trusts, on Equity, on Government and on the great tradition of English Common Law explain, in brilliant and simple prose, how the quintessential institutions of successful democracy and capitalism were established in England and then America. The Origins of the Modern World

This insistence upon immediate perception rather than abstract reasoning is what distinguishes the Indian philosophy of religion from philosophy as Western nations know it.

This fascinating and innovative book explores the relationship between the philosophical underpinnings of Advaita Vedanta, Zen Buddhism and the experiential journey of spiritual practitioners. Taking the perspective of the questioning student, the author highlights the experiential deconstructive processes that are ignited when students' "everyday" dualistic thought structures are challenged by the non-dual nature of these teachings and practices. Although Advaita Vedanta and Zen Buddhism are ontologically different, this unique study shows that in the dynamics of the practice situation they are phenomenologically similar. Distinctive in scope and approach *Advaita Vedanta and Zen Buddhism: Deconstructive Modes of Spiritual Inquiry* examines Advaita and Zen as living practice traditions in which foundational non-dual philosophies are shown "in action" in contemporary Western practice situations thus linking abstract philosophical tenets to concrete living experience. As such it takes an important step toward bridging the gap between scholarly analysis and the experiential reality of these spiritual practices.

Modern Arabic Drama in Egypt

Alan MacFarlane has studied the parishes of Earls Colne in Essex and Kirkby Lonsdale in Cumbria, as well as other parishes, and has undertaken anthropological fieldwork in a contemporary community in Nepal. In

collaboration with Sarah Harrison and Charles Jardine he has devised a method of collecting, breaking down and then reintegrating historical records in a way which makes it possible to answer some of the sociological, demographic, anthropological, geographical and other questions which interest many people. For the amateur historian or genealogist who wants to know about a village or family, the method makes it possible to find out almost everything that survives in historical documents concerning each person who lived in a village, each plot of land and house.

Early in *Proud Beggars*, a brutal and motiveless murder is committed in a Cairo brothel. But the real mystery at the heart of Albert Cossery's wry black comedy is not the cause of this death but the paradoxical richness to be found in even the most materially impoverished life. Chief among Cossery's proud beggars is Gohar, a former professor turned whorehouse accountant, hashish aficionado, and street philosopher. Such is his native charm that he has accumulated a small coterie that includes Yeghen, a rhapsodic poet and drug dealer, and El Kordi, an ineffectual clerk and would-be revolutionary who dreams of rescuing a consumptive prostitute. The police investigator Nour El Dine, harboring a dark secret of his own, suspects all three of the murder but finds himself captivated by their warm good humor. How is it that they live amid degrading poverty, yet possess a *joie de vivre* that even the most assiduous forces of state cannot suppress? Do they, despite their rejection of social norms and all ambition, hold the secret of contentment? And so this short novel, considered one of Cossery's masterpieces, is at once biting social commentary, police procedural, and a mischievous delight in its own right.

Alexis de Tocqueville was one of the greatest political scientists of all time. His *Democracy in America* (1835, 1840) and *Ancien Regime* (1856) are classics. Yet his work is not always easy to understand since it needs to be seen as a work which combines his essays, letters, travels and other materials. Through an examination of all of these, we can see that Tocqueville, more than any other thinker, understood the deep roots of individualism, equality and fraternity and in doing so the origins of the modern world.
