Is the EU Doomed?

The European Union is in crisis. Crippled by economic problems, political brinkmanship, and institutional rigidity, the EU faces an increasingly uncertain future. In this compelling essay, leading scholar of European politics, Jan Zielonka argues that although the EU will only survive in modest form - deprived of many real powers - Europe as an integrated entity will grow stronger. Integration, he contends, will continue apace because of European states' profound economic interdependence, historic ties and the need for political pragmatism. A revitalized Europe led by major cities, regions and powerful NGOs will emerge in which a new type of continental solidarity can flourish. The EU may well be doomed, but Europe certainly is not.

German Europe

The euro crisis is tearing Europe apart. But the heart of the matter is that, as the crisis unfolds, the basic rules of European democracy are being subverted or turned into their opposite, bypassing parliaments, governments and EU institutions. Multilateralism is turning into unilateralism, equality into hegemony, sovereignty into the dependency and recognition into disrespect for the dignity of other nations. Even France, which long dominated European integration, must submit to Berlin's strictures now that it must fear for its international credit rating. How did this happen? The anticipation of the European catastrophe has already fundamentally changed the European landscape of power. It is giving birth to a political monster: a German Europe. Germany did not seek this leadership position - rather, it is a perfect illustration of the law of unintended consequences. The invention and implementation of the euro was the price demanded by France in order to pin Germany down to a European Monetary Union in the context of German unification. It was a quid pro quo for binding a united Germany into a more integrated Europe in which France would continue to play the leading role. But the precise opposite has happened. Economically the euro turned out to be very good for Germany, and with the euro crisis Chancellor Angela Merkel became the informal Queen of Europe. The new grammar of power reflects the difference between creditor and debtor countries; it is not a military but an economic logic. Its ideological foundation is 'German euro nationalism' - that is, an extended European version of the Deutschmark nationalism that underpinned German identity after the Second World War. In this way the German model of stability is being surreptitiously elevated into the guiding idea for Europe. The Europe we have now will not be able to survive in the risk-laden storms of the globalized world. The EU has to be more than a grim marriage sustained by the fear of the chaos that would be caused by its breakdown. It has to be built on something more positive: a vision of rebuilding Europe bottom-up, creating a Europe of the citizen. There is no better way to reinvigorate Europe than through the coming together of ordinary Europeans acting on their own behalf.

Europe in the Global Age

Europe's social model – its system of welfare and social protection – is regarded by many as the jewel in the crown. It is what helps to give the European societies their distinctive qualities of social cohesion and care for the vulnerable. Over recent years, however, the social model has come under great strain in many states within the European Union – unemployment, for example, remains stubbornly high. The resulting tensions have fuelled dissatisfaction with the European project as a whole, culminating in the rejection of Europe's proposed new constitution. Reform of the social model is therefore a matter of urgency. It has to go hand in hand with the quest to regenerate economic growth. The weaker performers in Europe over the past few years can learn a good deal from states that have coped more effectively. But more radical changes need to be contemplated in the face of the impact of globalization, rapidly increasing cultural diversity and changing

demography. The author argues that the traditional welfare state needs to be rethought. We have to bring lifestyle change into the heart of what welfare means. Moreover, environmental issues must be directly connected to other citizenship obligations. These innovations have to be made at the same time as Europes competitive position is upgraded. This original and path-breaking book will rank alongside Beyond Left and Right, The Third Way and other works by Anthony Giddens that have helped reshape social and political thinking over recent decades.

Such a strengthened union could mark a new stage for democracy—not the democracy of ancient cities and modern states, but one convenient to the complex entities, neither national nor supra-national, of which the European Union, despite the crisis, is still the best modern example.

The Crisis of the European Union

Translated by Ciaran Cronin. In the midst of the current crisis that is threatening to derail the historical project of European unification, Jürgen Habermas has been one of the most perceptive critics of the ineffectual and evasive responses to the global financial crisis, especially by the German political class. This extended essay on the constitution for Europe represents Habermas's constructive engagement with the European project at a time when the crisis of the eurozone is threatening the very existence of the European Union. Now that the question of Europe and its future is once again at the centre of public debate, this important intervention by one of the greatest thinkers of our time will be of interest to a wide readership.

Theorising the Crises of the European Union

The EU after Brexit

Much attention has been paid to the ongoing and unpredictable Brexit negotiations between the EU and the UK, but much less on what the absence of the UK might entail for the remaining 27 EU Member States. This book explores the range of implications for the EU after Brexit, and whether it is likely to become stronger or weaker as a result. It reviews the different attitudes on the EU's future within both the member states and the individual EU institutions, and examines the impacts of Brexit on the composition of the EU institutions and on the balance of power between the member states. It also looks at linguistic and cultural impacts, the UK's wider legacy for the EU and possible changes in EU priorities. The author concludes that Brexit has reinforced the EU's unity in the short term, but that the EU will have to confront a number of key challenges if it is to be reinforced in the longer term. This book will appeal to practitioners, scholars and students interested in EU politics and integration in general, and Brexit in particular.

Research Handbook on European Social Security Law

Crises of European Integration

My cases comprise the crisis of the European Defence Community (1952-54); the empty chair crisis (1965-66); the oil crisis (1973-74); the budgetary rebate crisis (1979-84); the end of the Cold War crisis (1989-92); the Constitutional Treaty crisis (2004-07); the Euro crisis (2009-12); and the migration crisis (2015-16). Taking a historical-comparative perspective, the book shows that crises have been an integral part of the European integration process since its beginning. European integration, after all, started with a major setback when member states in 1954 failedto realize plans for a European army through the European Defense Community.

European Disintegration

Brexlit

Britain's vote to leave the European Union in the summer of 2016 came as a shock to many observers. But writers had long been exploring anxieties and fractures in British society – from Euroscepticism, to immigration, to devolution, to post-truth narratives – that came to the fore in the Brexit campaign and its aftermath. Euroskepticism as a fundamental and collectively mobilized opposition to processes of Europeanization; and fourth, the political sociology of crisis, linked not only to financial turmoil but also, more fundamentally, to a legitimation crisis that affects Europe and the democratic nation-state.

European Identity in the Context of National Identity

Leadership Styles in the European Council

Using the example of Werner Faymann, Dalia Grybauskaité, Angela Merkel, Viktor Orbán and Mark Rutte, the book examines the impact that the European Council's environment has on leadership styles and the impact of leaders on the institution's decision-making during the financial and debt crisis, the Ukraine crisis, and the migration crisis (2010-2016). Towards a Segmented European Political Order

This book makes a distinctive contribution to the crucial debate on the European Union (EU)'s present and future development. It systematically examines how the range of crises and challenges over the last decade have transformed the EU and relates those findings to the discussion of an increasingly differentiated EU. It argues that the post-crises EU shows clear signs of becoming a segmented political order with in-built biases and constraints. Differentiation and Dominance in Europe's Poly-Crises

Against the backdrop of a more differentiated European Union, this book discusses the relationship between differentiation and domination in the EU in relation to how it has been transformed through the financial and refugee crises, the COVID-19 pandemic, the Russian invasion of Ukraine, and in general, a more volatile and less rule-bound global context. In doing so, it assesses to what extent these adaptations represent significant change, generating new problems and challenges, or on the other hand, providing an opportunity for new solutions or even signalling a new approach to governance that can mitigate problems associated with domination. Differentiation is discussed not only from a legal perspective, but with special attention to

In Defence of Europe

Europe has not been so weak and divided for a long time. Buffeted by a succession of crises, it has shown a strong collective survival instinct but a poor capacity to deliver. In times when the tectonic plates are shifting and tension between global markets and national democracies is rising, can Europe hold together, under what termsand indeed for what purpose? The euro crisis has left big scars and is not over yet. Economic divergence has grown between and within countries, leading in turn to political fragmentation and the rise of populism. And growth remains slow, fragile, and uneven. Europe is in a bind: it is difficult to go forwards and scary to go backwards. In between, it is an unhappy and unstable state of affairs. Looking further afield, a more assertive Russia and an imploding neighbourhood may not even allow Europe the luxury to decline in grace. A convinced European and familiar with the world of Brussels, Loukas Tsoukalis is critical of the way Europe has handled its multiple crises in recent years. He addresses the key issues and difficult choices facing Europe today. Can Europe collectively manage globalization, combine growth with inclusive societies, and reconcile its apparent yearning for soft power with the often hard reality of the world outside? Individual countries cannot handle these challenges on their own. While knowing full well the difficulties in reaching a common European stance, Tsoukalis is also acutely aware of the consequences of failure.

Interregionalism and the European Union

Is the EU isolated within the emergent multipolar world? Concentrating on interregional relations and focussing on the European Union's evolving international role with regards to regional cooperation, this innovative book collects a set of fresh empirical analyses of interregional ties binding the EU with its Eastern and Southern neighbourhood, as well as with Asia, Africa and the Americas. The 25 leading authors from 5 continents have contributed original and diverse chapters and the book advances a novel theoretical 'post-revisionist' approach beyond both the Eurocentrism of 'Europe First' perspectives, as well as the Euroscepticism of those advocating to simply move 'Beyond Europe'.

Crisis and Renewal

This clear and comprehensive introduction to the European Union considers its development through the theme of crisis and renewal. John Van Oudenaren describes EU institutions and policies, both historically and as they relate to current events. He traces the renewal of the EU that was underway at the end of the 2010s following the euro, migration, and Brexit crises and the health, economic, and political crisis that subsequently hit the Union with unexpected force in the coronavirus pandemic of 2020–2021. Exploring how institutions and policies are adapting to unprecedented political, economic, and geopolitical challenges, the author focuses on two key EU priorities—digitization and the transition to a carbon neutral future. These, he argues, are both intrinsic policy goals and the means by which the Union hopes to ensure its revitalization and its emergence as a "sovereign" power, taking its place alongside the United States and China as one of the big three players in global politics. Explaining the different theoretical perspectives used to understand the EU, the book gives students the tools they need to assess whether the Union is on a path to recovery and renewal.

The Pursuit of Europe

The story of the evolution of the \"European project\

Brexit, President Trump, and the Changing Geopolitics of Eastern Europe

This book analyzes the combined consequences of Brexit and of the new US foreign policy under President Trump on the geopolitical situation of Eastern Europe. It perceives the evolution of the East European regional security complex as a struggle between the European Union's Kantian, win-win geopolitical vision and Russia's neoclassical geopolitics, also promoted by President Trump. In the most probable scenario, the latter approach will have the upper hand. The EU's post-Brexit control by the Franco-German axis will likely be followed by the geopolitical irrelevance of the EU due to the renationalization of member states' foreign policy, with Germany becoming the main West European actor. Consequently, Eastern Europe will be turned into the arena of a mainly three-cornered neoclassical geopolitics rivalry opposing Russia, the Franco-German axis and then Germany, and the US in alliance with the post-Brexit UK and certain East European states. The book will appeal to scholars across the fields of International Relations, Geopolitics, European Studies, and Area Studies.

Exploring the EU's Legitimacy Crisis

Exploring the EU's Legitimacy Crisis provides a profound analysis of the causes and the consequences of the EU's growing legitimacy problem. The prior permissive consensus in the EU has been markedly declining under persistent crisis conditions. Since the onset of the eurozone crisis the EU's governance has been narrowly driven by the semi-hegemonial leadership of Germany – manifesting itself in functionalist and technocratic policy reforms concentrated on strengthening economic governance coordination. Other crucial policy areas have been neglected as member states show decreasing solidarity and a growing emphasis on national interests in response to mounting external challenges. This book examines these developments in detail by scrutinising the EU's ability to maintain legitimacy through political leadership, democratic accountability and governance efficiency.

European Security Policy and Strategic Culture

With the Lisbon Treaty in place and the European Union increasingly involved in international crisis management and stabilization operations in places near and far, this volume revisits the trajectory of a European strategic culture. Specifically, it studies the usefulness of its application in a variety of circumstances, including the EU's operations in Africa and the Balkans as well as joint operations with NATO and the United Nations. The contributors find that strategic culture is a useful tool to explain and understand the EU's civilian and military operations, not in the sense of a 'cause', but as a European normative framework of preferences and constraints. Accordingly, classical notions of strategic culture in the field of international security must be adapted to highlight the specific character of Europe's strategic culture, especially by taking the interaction with the United Nations and NATO into account. Though at variance over the extent to which security and defence missions have demonstrated or promoted a shared strategic culture in Europe, the authors reveal a growing sense that a cohesive strategic culture is critical in the EU's ambition of being a global actor. Should Europe fail to nurture a shared strategic culture, its actions will be based much more on flexibility than on cohesion. This book was published as a special issue of Contemporary Security Policy.
