# Defectors

# **Defectors and the Liberal Party 1910–2010**

This book is the first analysis of political defections over a long time span. It investigates all the Liberal/Liberal Democrat MPs and former MPs who defected from the party between the elections of December 1910 and May 2010 - around one sixth of all those elected - as well as the smaller number of inward defectors. Each of the 122 defections was an expert judgment on the state of the party at a specific date. The research investigates the timing and reasons for all the defections and reveals long-term trends and underlying causes and apportions responsibility between leaders for them. The author finds some significant differences which distinguished defectors from loyalists and draws wider conclusions about the underlying factors which lead MPs to defect. This book will be of interest to students and lecturers of British politics and anyone interested in the relationship between British political parties in the last century.

A well-informed defector is the most dangerous counter-intelligence commodity because it takes a spy to catch a spy. Very occasionally, an agent, especially a mole or an intelligence professional, will make a mistake and incriminate themselves, but usually it is a denunciation, a tip, or a vague clue from a defector that will provide the vital information required to expose the source of a leak. Relying on recentlydeclassified intelligence files and interviews with defectors, their handlers, their families, and their victims, Nigel West has analyzed nine examples of wartime and postwar defections to shed new light on the phenomenon. Defectors are notoriously difficult to handle, and resettle, because of the range of genuine or invented motives that led them to take such drastic action. Some will provide a noble political motive, seeking to impress their host, while others may be driven by less worthy compulsions – perhaps greed, revenge, career disappointment, envy, anger, or nothing more complicated that a desire to start a life afresh with a different partner. Defectors are the stock-in-trade for all counter-intelligence specialists who seek the background and context of corridor gossip and water-cooler chat cannot be substituted by any amount of technical surveillance, overhead reconnaissance or hard to-interpret intercepted communications. This is the essence of Human Intelligence, and goes to the heart of loyalty, trust, betrayal and deception - the very DNA of espionage. These nine examples of switching sides all involve intelligence professionals who followed the example of Erich Vermehren. Because of his religious convictions, Vermehren felt compelled to desert the Abwehr in January 1944, even though this meant the arrest of his parents and siblings who were consigned to Sachsenhausen concentration camp. West traced Vermehren, then living under an alias in Switzerland, to hear his story first-hand. He then interviewed the British MI6 officer who had engineered the covert exfiltration from Istanbul of both the German and his wife. Sometimes a defection may be the result of a period of cultivation, as happened with Vladimir Petrov, who was gently persuaded over many months by his Polish dentist to abandon his clandestine role as rezident in Canberra for a chicken farm. The intermediary, Dr Michael Bialoguski, admitted to the author that right up to the moment of his defection, he and his Australian Security Intelligence organization colleagues were not entirely sure of Petrov's true status. Once resettled, a defector's life has daily challenges, as was explained by Yuri Rastvorov's widow, herself a CIA counter-intelligence officer, who recalled the day she had to tell their two daughters that their father was not a Czech tennis coach, but an NKVD defector who had been based in Tokyo.

# **The Defectors**

Originally compiled and written by North Korean defector and author Lim II, this English-language edition, thoroughly annotated by Dr. Adam Zulawnik, is a fascinating collection of 34 interviews with highly prominent North Korean defectors residing in South Korea, ranging from religious figures, to artists, politicians, North Korea experts, and even divers and subway train operators. The 33 interviews herein are listed chronologically according to the interviewees' date of arrival to South Korea and span almost 70 years. The book also includes six special columns addressing key issues pertaining to North Korean defectors and their lives in South Korea, such as the relationship between North Korean defectors and their South Korean counterparts (South Korean defectors to North Korea; nomenclature (how North Korean defectors have been referred to in South Korean society over time); arrival and settlement provisions from the South Korean government; the nuanced difference between defectors, defector-residents, and the displaced; North Korean defector-residents and their position in South Korean politics; and a short biography of five notable North Korean defector-residents who were not interviewed. The English translation also contains an exclusive 34th interview with Lim II, the source text author which was carried out towards the end of the project in October 2020. The book is a valuable testament to North Korean defector-residents and unique in that it provides a candid account of each individual's experience. It will prove to be especially useful to students and scholars seeking to understand the complex dynamics of North Korean society and the status of exiles in South Korea, and a vital resource for students of Korean Studies.

## **Interviews with North Korean Defectors**

The topic of defection is taboo in the USSR, and the Soviets, are anxious to silence, downplay, or distort every case of defection. Surprisingly, Vladislav Krasnov reports, the free world has often played along with these Soviet efforts by treating defection primarily as a secretive matter best left to bureaucrats. As a result, defectors' human rights have sometimes been violated, and U.S. national security interests have been poorly served.

# **Leaving Berlin**

Stalin's Defectors is the first systematic study of the phenomenon of frontline surrender to the Germans in the Soviet Union's 'Great Patriotic War' against the Nazis in 1941-1945. No other Allied army in the Second World War had such a large share of defectors among its prisoners of war. It shows that the most widespread sentiments animating attempts to cross the frontline was a wish to survive this war. Disgruntlement with Stalin's 'socialism' was also prevalent among those who chose to give up and hand themselves over to the enemy. While politics thus played a prominent role in pushing people to commit treason, few desired to fight on the side of the enemy. Hence, while the phenomenon of frontline defection tells us much about the lack of popularity of Stalin's regime, it does not prove that the majority of the population was ready for resistance, let alone collaboration. Both sides of a long-standing debate between those who equate all Soviet captives with defectors, and those who attempt to downplay the phenomenon, then, over-stress their argument. Instead, more recent research on the moods of both the occupied and the unoccupied Soviet population shows that the majority understood its own interest in opposition to both Hitler's and Stalin's regime. The findings of Mark Edele in this study support such an interpretation.

## **Soviet Defectors**

Why is religion so widespread? Why do individuals donate large amounts of time, money, and effort to religious groups? What forms does the religious competition take? This book provides a non-technical introduction to how the economic approach answers these and other questions about religion. It defines the economic approach to religion and demonstrates how it is used to study a variety of religious decisions. It explains how religious groups confront credibility, free-rider, and coordination problems that challenge the collective production of religious goods and services. It also examines competition and regulation in religious markets around the world, how religious beliefs and preferences are transmitted and sustained, how religion likely emerged in humankind's distant past, and what the future of religion may hold. The book thus demonstrates how the tools and methods of economics provide fresh insight into a variety of religious behaviors. This book is intended for a wide audience in and out of economics. Though not a textbook per se, its discussion questions and suggested readings at the end of each chapter allow for easy incorporation into the classroom. The mathematics and statistics used by researchers are generally avoided. Both theory and evidence are presented, but the focus is on the ideas that provide a coherent conceptual framework that grounds a deeper exploration of the theoretical and empirical research in the economics of religion.

His book presents a range of analytical tools that can be used to this end: fitness landscapes, mutation matrices, genomic sequence space, random drift, quasispecies, replicators, the Prisoner's Dilemma, games in finite and infinite populations, evolutionary graph theory, games on grids, evolutionary kaleidoscopes, fractals, and spatial chaos. Nowak then shows how evolutionary dynamics applies to critical real-world problems, including the progression of viral diseases such as AIDS, the virulence of infectious agents, the unpredictable mutations that lead to cancer, the evolution of altruism, and even the evolution of human language. His book makes a clear and compelling case for understanding every living system—and everything that arises as a consequence of living systems-in terms of evolutionary dynamics.
