# Ordeal

The former good girl who became the star of Deep Throat tells the horrifying true story of her life on and off camera in this shocking tell-all memoir. Linda Boreman was just twenty-one when she met Chuck Traynor, the man who would change her life. Less than two years later, the girl who wouldn't let her high school dates get past first base was catapulted to fame as an adult film superstar. Linda Boreman of Yonkers, New York, had become Linda Lovelace. The unprecedented success of Deep Throat made pornography popular with mainstream audiences and made Lovelace a household name. # **Ordeal by Slander**

Joseph McCarthy was not yet a household name in 1950 when Owen Lattimore was labeled by the senator from Wisconsin as the "top Russian espionage agent in the country." Lattimore, in Kabul, Afghanistan, learned about the accusation a week later. Having already lost valuable time to rebut the smear, he succinctly cabled back that the charge was "pure moonshine," and returned to the United States to defend his good name. He soon dared McCarthy to utter his slander in a venue other than the Senate, where congressional immunity shielded him from lawsuits, but he refused to do so. Following a torturous Senate inquisition, Lattimore published this riveting book which he wrote in white-hot indignation. Judged at the time to be "a masterpiece of factual exposition [and] a social document of first-rate importance,"\* this absorbing narrative chronicles how the ordeal threw Lattimore's life into perilous straits, and how he defended himself, while undermining the credibility of his accusers. In a battle for his very liberty, Lattimore prepared for the equivalent of an alley fight with the brawling senator. His supremely competent wife, Eleanor, was his trusted aide; along with attorney Abe Fortas they drew out of Lattimore's writings passages that would prove his loyalty. Yet, as a scholar who was accustomed to nuanced interpretations of current affairs, his accusers were able to conflate the same writings into a traitor's hidden agenda. Ordeal by Slander was the first great book to come out of the McCarthy era, and it remains a supremely topical book for today. # The Ordeal

# Parchman Ordeal, The: 1965 Natchez Civil Rights Injustice

In October 1965, nearly 800 young people attempted to march from their churches in Natchez to protest segregation, discrimination and mistreatment by white leaders and elements of the Ku Klux Klan. As they exited the churches, local authorities forced the would-be marchers onto buses and charged them with \"parading without a permit,\" a local ordinance later ruled unconstitutional. For approximately 150 of these young men and women, this was only the beginning. They were taken to the Mississippi State Penitentiary in Parchman, where prison authorities subjected them to days of abuse, humiliation and punishment under horrific conditions. Most were African Americans in their teens and early twenties. Authors G. Mark LaFrancis, Robert Morgan and Darrell White reveal the injustice of this overlooked dramatic episode in civil rights history.

#### The Ordeal

The use of ordeals and sworn oaths to prove one's innocence invites trickery. The guilty trickster cannot influence the judgment of the divine powers, but he can--by disguise or by equivocation in wording the oath--create a presumption of innocence. Ralph Hexter surveys the varieties of such stories in a number of folk literatures and looks at the use of this motif in three important medieval story cycles, with special attention to the way Christian writers handled story material based on a pre-Christian act of truth.

#### Equivocal Oaths and Ordeals in Medieval Literature

Between 1910 and 1920, the Chicago Federation of Labor (CFL) inaugurated a massive organizing drive in the city's meatpacking and steel industries. Although the CFL sought legitimately progressive goals, worked earnestly to organize an interracial union, and made major inroads among both black and white workers, their efforts resulted in a bitter defeat. David Bates provides a clear picture of how even the most progressive of intentions can be ground to a halt. By organizing workers into neighborhood locals, which connected workplace struggles to ethnic and religious identities, the CFL facilitated a surge in the organization's membership, particularly among African American workers, and afforded the federation the opportunity to aggressively confront employers. The CFL's innovative structure, however, was ultimately its demise. Linking union locals to neighborhoods proved to be a form of de facto segregation. Over time union structures, rank-and-file conflicts, and employer resistance combined to turn the union's hopeful calls for solidarity into animosity and estrangement. Tensions were exacerbated by violent shop floor confrontations and exploded in the bloody 1919 Chicago Race Riot. By the early 1920s, the CFL had collapsed. The Ordeal of the Jungle explores the choices of a variety of people while showing a complex, overarching interplay of

black and white workers and their employers. In addition to analyzing union structures and on-the-ground relations between workers, Bates synthesizes and challenges previous scholarship on interracial organizing to explain the failure of progressive unionism in Chicago.

# **Ordeal by Ice**

Abandoned by her parents, brought up by her strict maternal grandmother in a small backwater town, young Beatrice Saubin always dreamed of visiting warm climates and exotic places. As a teenager she hitchhiked to India and later to Afghanistan and Thailand. In Malaysia, at age nineteen, she fell in love with Eddy Tan Kim Soo, a handsome, wealthy Chinese man. They planned to meet in Europe and marry. But at the airport on her way home, her spanking new Samsonite suitcase—a gift from Eddy— was ripped apart by custom officials. Beatrice was horrified to see that it contained several kilos of heroin. Clearly she had been set up by Eddy, who, it turned out, was a member of a powerful drug cartel. Arrested, Beatrice languished in prison for two years before she was tried. Her sentence: death by hanging. On appeal, her sentence was reduced to life in prison. Efforts on the part of her grandmother and an impassioned attorney managed to stir up public opinion, finally leading to Beatrice's release after ten years. But however terrible, these years were not lost. While in prison, her spirits were never broken: she taught herself Malaysian and Cantonese, and became a model prisoner and a leader as well as a medical supervisor, caring for her fellow inmates. The Ordeal is her odyssey—always gripping, often terrifying, but ultimately a story of courage and inspiration.

# The Ordeal

How the United States underdeveloped Appalachia Appalachia—among the most storied and yet least understood regions in America—has long been associated with poverty and backwardness. But how did this image arise and what exactly does it mean? In Ramp Hollow, Steven Stoll launches an original investigation into the history of Appalachia and its place in U.S. history, with a special emphasis on how generations of its inhabitants lived, worked, survived, and depended on natural resources held in common. Ramp Hollow traces the rise of the Appalachian homestead and how its self-sufficiency resisted dependence on money and the industrial society arising elsewhere in the United States—until, beginning in the nineteenth century, extractive industries kicked off a "scramble for Appalachia" that left struggling homesteaders dispossessed of their land. Stoll ranges widely from literature to history to economics in order to expose a devastating process whose repercussions we still feel today.

# Ordeal

In this remarkable reconstruction of an eighteenth-century woman's extraordinary and turbulent life, historian Linda Colley not only tells the story of Elizabeth Marsh, one of the most distinctive travelers of her time, but also opens a window onto a radically transforming world.Marsh was conceived in Jamaica, lived in London, Gibraltar, and Menorca, visited the Cape of Africa and Rio de Janeiro, explored eastern and southern India, and was held captive at the court of the sultan of Morocco. She was involved in land speculation in Florida and in international smuggling, and was caught up in three different slave systems. She was also a part of far larger histories. Marsh's lifetime saw new connections being forged across nations, continents, and oceans by war, empire, trade, navies, slavery, and print, and these developments shaped and distorted her own progress and the lives of those close to her. Colley brilliantly weaves together the personal and the epic in this compelling story of a woman in world history.

#### The Ordeal of Elizabeth Marsh

A book written in 1939 and later discovered and rescued by Waterside Press - that gives a detailed account of the often barbaric or shameful punishments used in former times. Since this book was first published in the 1950s the description it contains of the history of crime and punishment in Britain over the previous 200 years or so has attracted interest across a wide spectrum. The work was reprinted in 1992 by Waterside Press having been out of print for decades. The contents cover a wide range of historic punishments from outlawry to the ducking stool, the pillory, stocks and whirligig to the branding iron and scold's bridle. From mutilation and torture to sanctuary and the emergence of private and then public prisons this is an essential addition to any criminal justice collection - imbued as it is by the comments of the author from the perspective of his own era, which provides for fascination in itself. Printed in the original style and format - together with a large number of the original illustrations. Quite absorbing - The book transports the reader to a time when punishments were often brutal, unrestrained and unregulated by standards, fairness or consistency. It also looks at the sometimes strange logic that was applied by judges, justices of the peace and those charged with carrying out the task.

#### **This Terrible Ordeal**

This book describes the development of the criminal law of evidence in the Netherlands, France and Germany between 1750 and 1870. In this period the development occurred that the so-called system of legal proofs was replaced with the (largely) free evaluation of the evidence. The system of legal proofs, which had functioned since the late middle ages, consisted of a set of strict evidentiary rules which predetermined when a judge could convict someone. In this book an explanation is given of the question why between 1750 and 1870 the strict evidentiary rules were replaced with the free evaluation of the evidence. The thesis of this research is that the reform was induced by a change in the underlying epistemological and political-constitutional discourses which together provided the ideas which inspired a significant reform of the

criminal law of evidence.

#### Expectation

Well after the condemnation of ordeals by the Fourth Lateran Council, the Kunigunde legend preserves the ordeal by fire in a sort of hagiographic amber, much as it was portrayed in the mid-twelfth-century Richardis legend, while Stricker's short secular burlesque \"The Hot Iron,\" written in the mid-thirteenth century, makes sport of this formerly serious legal proceeding, reflecting the almost immediate abandonment of trial by fire as a legal proof in many areas after the council's decision.\"

# A Mother's Ordeal

Peggy McCracken offers a feminist historicist reading of Guenevere, Iseut, and other adulterous queens of Old French literature, and situates romance narratives about queens and their lovers within the broader cultural debate about the institution of queenship in twelfth- and thirteenth-century France. Moving among a wide selection of narratives that recount the stories of queens and their lovers, McCracken explores the ways adultery is appropriated into the political structure of romance.
